The attention of the all the District Educational Officers in the State are invited to the reference read above, wherein the Hon'ble MLC Sri G. Srinivasulu Naidu, PRTU Front Floor Leader, Andhra Pradesh Legislative Council has informed that 50,000 posts were notified in DSC – 2008. But due to non-availability of posts at district level, posts were filled up in phased manner i.e. some posts were filled up in November, 2010 and others were filled up from June, 2011 to January, 2012. Though all of them were selected in same DSC i.e. DSC 2008, the candidates appointed afterward are losing seniority and losing promotions. Therefore, the Hon'ble MLC has requested to treat all the candidates selected and appointed in DSC 2008 with common seniority.

In view of the above, all the District Educational Officers are requested to furnish the details of the number of candidates appointed spell wise in DSC 2008 in the following proforma to examine further.
