**ORDER:**

In the reference 1<sup>st</sup> read above, Government have constituted Mangalagiri Tadepalli Municipal Corporation by merging Mangalagiri Municipality, Tadepalli Municipality and 21 Grampanchayats with a population of 2,53,831 as per Census 2011.

2. In the reference 2<sup>nd</sup> read above, Government have classified the rates of House Rent Allowance (HRA) based on the Census figures of 2011. The Cities and Towns having the population between 2.00 lakhs to 50.00 lakhs are eligible to draw HRA @ 16% of Basic Pay subject to a maximum of Rs. 17,000/-.

3. The Employees Associations have requested the Government to sanction HRA @16% to all State Government Employees working in Mangalagiri Tadepalli Municipal Corporation (MTMC) area, as per orders issued vide reference 2<sup>nd</sup> cited, as the population of the Mangalagiri, Tadepalli Municipal Corporation area is 2,53,831 and therefore eligible for HRA @ 16% HRA i.e., population criteria of 2 lakhs to 50 lakhs.

4. Government, after careful examination of the matter, hereby order to enhance the House Rent Allowance (HRA) from the existing 12% to 16% in respect of all State Government Employees working in Mangalagiri - Tadepalli Municipal Corporation (MTMC) area subject to a maximum of Rs.17,000/- per month.

5. These orders shall be applicable with effect from 01.11.2023.

6. All other terms & conditions relating to House Rent Allowance (HRA) mentioned in the reference 2<sup>nd</sup> read above shall remain applicable.

**ORDER:**

- In the reference 1<sup>st</sup> read above, orders were issued revising the rates of House Rent Allowance (HRA) in supersession of the orders issued at para 8 of GO Ms No.1 Fin (PC-TA) Department dated 17.01.2022.
2. In the reference 2<sup>nd</sup> read above, the Government have issued the final Gazette Notifications relating to the restructuring of the existing Districts & Revenue Divisions in the State, & inter-alia Parvathipuram, Paderu, Amalapuram, Bhimavaram, Bapatla, Narsaraopeta, Puttaparthi and Rayachoty have become the District headquarters of restructured districts.
  3. The aforementioned District headquarters do not fulfill the population parameters stipulated for sanction of HRA @ 16%, & the HRA is allowed @ 12% in PRC 2022.
  4. In the reference 3<sup>rd</sup> read above, the Employees working in the aforementioned District headquarters have requested to extend the HRA @ 16% to all the District headquarters in the State, in relaxation of the stipulated population parameters, on the analogy of the (13) erstwhile District headquarters.
  5. Government, after careful examination of the matter, hereby order to enhance the House Rent Allowance (HRA) from the existing 12% to 16% in respect of the District headquarters of Parvathipuram, Paderu, Amalapuram, Bhimavaram, Bapatla, Narsaraopeta, Puttaparthi & Rayachoty.
  6. These orders shall be applicable with prospective effect from 01.06.2023.

**ORDER:**

Government have issued Comprehensive Orders on implementation of 11<sup>th</sup> PRC Revised Pay Scales, 2022 vide reference 1<sup>st</sup> read above. Revised House Rent Allowance (HRA) has been sanctioned at para 8 of the same.

2. In the reference 2<sup>nd</sup> read above, Government have constituted a Committee (Ministers Committee) to deliberate with the Employees' Associations and to clear the apprehensions of the Employees about orders of the Government on the Pay Revision Commission and to sort out the connected issues. Based on the representations received from the Employees Associations, the Ministers Committee proposed to revise the House Rent Allowance (HRA) vide the reference 4<sup>th</sup> read above.

3. Government, after careful consideration of the entire matter & keeping in view the welfare of the employees, have decided to revise the rates of House Rent Allowance (HRA) in supersession of the orders relating to House Rent Allowance (HRA) at para 8 of G.O.Ms.No.1, Finance (PC-TA) Department, dated: 17.01.2022.

4. Accordingly, Government hereby order the revised rates of House Rent Allowance (HRA) as detailed below.

5. The census figures of 2011 will be taken into consideration for classification under different categories for purpose of drawl of House Rent Allowance.

6. The revised HRA rates are applicable to:

- a. Employees of the State Government.
- b. Employees of Local Bodies and Aided Institutions, including Aided Polytechnics, in respect of those drawing pay in regular pay scale in the Revised Pay Scales, 2022; and
- c. The Work-charged establishment in respect of those drawing pay in Revised Pay Scales of 2022.

7. For all employees & officers, HRA is given as per their respective Pay Commission rules which are in force.
8. The existing rules vide the 3<sup>rd</sup> reference read above regarding payment of House Rent Allowance at the rates applicable to the places located within the periphery of 8 KMs from the towns / cities concerned based on the Notification issued by the District Collector concerned shall continue. A fresh notification shall be issued by the District Collector immediately duly following the prescribed procedure.
9. Separate Orders will be issued in respect of officers of the Andhra Pradesh Higher Judicial Services and Andhra Pradesh State Judicial Services. Separate Orders will also be issued for the employees of Secretariat and Head of Departments.
10. These orders shall come into force with effect from 01-01-2022.
11. The Government will issue necessary amendments to the Andhra Pradesh Public Employment (House Rent Allowance) Rules 1988.

**ORDER:**

In the reference second cited above, the Government of Andhra Pradesh constituted the Tenth Pay Revision Commission (PRC). The PRC, after extensive consultations with the employees' representatives and due consideration of the pay and allowances of the public servants, has made certain recommendations.

2. The Government, after due consideration of the recommendations of the PRC, hereby orders the following:

- i) the existing classification of cities, towns and the rates of allowance ordered in G.O. MS. No. 64 dated: 09.03.2010 and G.O.MS.No.59, dated: 11.04.2011 of Finance (PC-I) Department, shall be retained for the purpose of admissibility of House Rent Allowance as indicated below.

ii) The above entitlement shall be subject to a ceiling of Rs.20,000 per month for employees working and living in the Greater Hyderabad Municipal Corporation. For other places, the ceiling of HRA shall be Rs.15,000.

3. These orders are applicable to:

- i) Employees of the State Government;
- ii) Employees of Local Bodies and Aided Institutions, including Aided Polytechnics, in respect of those drawing pay in regular pay scale in the Revised Pay Scales of 2015; and
- iii) Work-charged establishment in respect of those drawing pay in regular pay scale in the Revised Pay Scales of 2015.

4. The revised HRA rates being ordered in this Government Order shall not be applicable to the following categories of employees, who shall continue to draw the allowance at the existing rates:

- i) Teachers working in the Universities, affiliated degree colleges both under Government and Aided managements who are drawing pay in the UGC/ ICAR/ AICTE pay Scales;
- ii) Officers of All India Services (AIS);

5. Separate Orders will be issued in respect of officers of Andhra Pradesh Higher Judicial Services and Andhra Pradesh State Judicial Services. These orders shall not apply to the Police personnel in the rank of Inspectors and below for whom separate orders will be issued by the Home Department.

6. These orders shall come into force with effect from June 02, 2014. The revised rates of HRA shall be paid in cash along with the salary in the Revised Pay Scales 2015, from the month of April 2015.

7. The Government will issues necessary amendments to the Andhra Pradesh Public Employment (House Rent Allowance) Rules 1988.

**ORDER:**

In the Government order first read above, orders were issued implementing the recommendations of the Ninth Pay Revision Commission on the House Rent Allowance. Subsequently, an agreement was reached between the Government and the Joint Action Committee of Employees, Teachers, Workers and Pensioners of A.P. Among other things, it was agreed therein that the House Rent Allowance be enhanced to 14.5% at places where House Rent Allowance is admissible at 12.5% at present and to 12% in respect of places where HRA is admissible at 10% at present. Accordingly, in partial modification of the orders in the reference first read above, Government hereby order enhancement of House Rent Allowance to 14.5% at places where House Rent Allowance is admissible at 12.5% at present and to 12% in respect of places where HRA is admissible 10% at present.

2. The enhanced rates of House Rent Allowance shall come into force with effect from 1.4.2011.
3. As such, the rates of House Rent Allowance at various places shall be as under from 01.04.2011:



In the Cir. Memo.1<sup>st</sup> cited above, the practice of allowing House Rent Allowance, to the employees, at the rates as admissible in the qualifying towns to those working in offices which are situated within 8 kms. radius of the qualifying town is being followed since 1971.

2. In the reference 2<sup>nd</sup> cited above, necessary Rules were issued regarding allowing H.R.A., applicable to a Qualified City/Town, to the Employees working in the villages around 8 kms periphery of a Qualified City/Town subject to certain conditions.

3. In the G.O. 5<sup>th</sup> cited above, the HRA is enhanced from 20% to 30% to the employees working in the Greater Hyderabad Municipal Corporation consequent to the up-gradation of GHMC as A-1 Class City by the Govt. of India vide their O.M.No.2(21)/2007-E.II(B), dt.31-08-2007 of Dept. of Expr., Ministry of Finance.

4. In the reference 6<sup>th</sup> cited above, as per the request of the District Collectors of Rangareddy, Visakhapatnam, Adilabad and East Godavari districts, they are permitted to issue necessary notifications subject to the conditions laid down in the reference 2<sup>nd</sup> cited above, so as to enable the employees to draw the HRA applicable to a Qualified City/Town, who are working around 8 kms periphery of a Qualified City/Town.

5. In the reference 7<sup>th</sup> cited above, it has been requested to issue necessary orders which shall be applicable to all the districts, to allow the HRA applicable to a Qualified City/Town, to the Employees working in the villages around 8 kms periphery of that Qualified City/Town.

6. In the references 8<sup>th</sup> and 9<sup>th</sup> cited above, it has been requested to issue necessary orders which shall be applicable to the employees of Medak district working in the villages around 8 kms periphery of the GHMC.

7. After careful examination, Government hereby authorise all the District Collectors in the State to notify the villages situated within 8 kms periphery of the municipal limits of the qualified cities/ towns as per orders issued and conditions laid down in the note under para 3 of the G.O. 2<sup>nd</sup> cited above, for the limited purpose of extending the same rates of HRA as existing in the qualified cities/ towns. The District Collectors shall notify such villages falling within 8 kms. of the contiguity from the periphery of the qualified Municipal Cities/Towns and also as and when new qualified cities/ towns are declared or the limits of existing qualified cities/ towns are altered, for the purpose of allowing HRA to the employees, duly following the procedure mentioned above.

8. The monetary benefit shall accrue from the date of issue of the notifications by the respective District Collectors.

**ORDER:**

In the Government Order second read above, orders were issued constituting Ninth Pay Revision Commission, appointing Sri C.S.Rao, I.A.S. (Retd) as Pay Revision Commissioner. Subsequently, additional terms of references were included vide G.O third read above. The Pay Revision Commission submitted its report to the Government on 05.12.2009.

2. The Ninth Pay Revision Commission interalia recommended the following on House Rent Allowance:

- (i) The existing classification of cities and towns as also the rates of allowance be retained for the purpose of admissibility of HRA.
- (ii) The existing ceiling of Rs.6000/- be enhanced to Rs.12000/- per month for Greater Hyderabad Municipal Corporation.
- (iii) For other places where ceiling is Rs.4000/- be enhanced to Rs.8000/- per month.
- (iv) The existing rules with regard to the payment of HRA at the rates applicable to the places located within the periphery of 8 KMs for the towns / cities concerned be continued.
- (v) Only decennial census figures should be taken into consideration for classification under different categories for purpose of drawal of HRA.

3. Government have accepted the above recommendations. Accordingly, it is hereby ordered that -

- (a) The existing classification of cities, towns and the rates of allowance ordered in G.O.(P).No.230, dated 15.09.2005, G.O.(P).No.456 dated: 08.12.2005, G.O.(P).No.181, dated 29.06.2006 and in G.O.(P).No.10 dated: 17.01.2008 of Finance (PC-I) Department, shall be retained for the purpose of admissibility of House Rent Allowance as indicated below:

ORDER

In the G.O. 8th read above, orders were issued, based on the recommendations of the Pay Revision Commissioner 1993, implementing the Revised Pay Scales 1993 with effect from 1.1.1993 with monetary benefit from 1.4.1993.

2. The Pay Revision Commissioner reviewed the pattern of payment of House Rent Allowance to the Government employees over the past two decades. The Commission has also gathered certain information on the trends in the increases in the

house rents in selected towns and cities of the State. The Commission has observed that the merger of D.A. while evolving revised pay scales would increase the basic pay by 83%. If the percentages of House Rent Allowance admissible in different towns on the 1986 pay scales were to remain unchanged, it would lead to an increase of House Rent Allowance by 83% over current levels. The Commission felt that such a large increase is not justified by the quantum of increase in rents as aforementioned. The Commission has therefore marginally adjusted the percentage rates downwards. After such adjustment the average increase in House Rent Allowance over current rates would still be 55% which should be adequate considering the increase in rents in the recent years. Taking an overall view of the matter, the Pay Revision Commissioner has recommended that:

(a) House Rent Allowance may be paid to the Government employees working at the following places at the rates shown below:

Hyderabad and Secunderabad, Visakhapatnam, Vijayawada, Warangal, Guntur, Rajahmundry, Nellore, Kakinada, Kurnool, Tirupathi, Nizamabad and Eluru.

16% of Basic pay

Srikakulam, Vizianagaram, Machilipatnam, Ongole, Chittoor, Anantapur, Cuddapah, Adilabad, Karimnagar, Mahaboobnagar, Khammam, Sangareddy and Nalgonda.

10% of Basic pay

All other places 8 percent of Basic pay

(b) to adopt the published decennial figures as the firm basis for purposes of classification of cities and towns as adoption of mid census estimates would lead to avoidable confusion and wrangling over population of cities and towns and consequently on the rates of HRA to be applied.

(c) the existing scheme i.e. for employees whose place of duty is within 8 kms periphery of municipal limits the HRA applicable in that municipality is paid, does not require any modification, except to the extent that a certificate from the EE, R&B concerned is required every time a new office comes in the area. This certificate should be obtained by each drawing and disbursing officer. To avoid inconvenience to the employees, the village falling within 8 KMs of the town may be notified by the Collector by obtaining the certificate from the concerned Executive Engineer (R&B) and this

notification should be sufficient to enable the staff to draw the HRA. This would be a one time task and would change only when the Municipal limits are altered.

3. Government have accepted the above recommendations of the Pay Revision Commissioner and hereby order as follows.

(a) (i) House Rent Allowance shall be admissible at 16% of basic pay to the employees in cases where the place of duty is in Twin Cities of Hyderabad and Secunderabad, Visakhapatnam, Vijayawada, Warangal, Guntur, Rajahmundry, Nellore, Kakinada, Kurnool, Tirupathi, Nizamabad and Eluru.

(ii) House Rent Allowance shall be admissible at 10% of basic pay to the employees in case where the place of duty is Srikakulam, Vizianagaram, Machilipatnam, Ongole, Chittoor, Anantapur, Cuddapah, Adilabad, Karimnagar, Mahaboobnagar, Khammam, Sanagareddy and Nalgonda.

Note: The House Rent Allowance shall also be admissible at the rates specified in 9(a) (i) & (ii) above to those employees working in offices and institutions which are situated in villages falling within 8 Kms. of the periphery of the qualified towns subject to the following conditions:

A. For this purpose, the distance shall be computed along the nearest route, by a Public Road, between the Municipal limits of the qualified town and the centre of the inhabited area of the village. Thus the offices in a village shall be eligible if the distance so computed is less than 8 Kms.

B. the Dist. Collector shall notify such villages in respect of each qualified town by obtaining the list of such villages from the Executive Engineer, (R&B) concerned.

(iii) In all the other places the House Rent Allowance shall be admissible at 8% of pay.

(b) The House Rent Allowance shall be subject to a maximum of Rs. 1,000 per month.

(c) The decennial figures published by the Director General, Census Operations, Government of India shall form the base for classification of cities and towns for purpose of allowing House Rent Allowance.

(d) House Rent Allowance is not admissible to Government servants provided with rent free quarters or to Government servants who have been provided with Government quarters or quarters on payment of reduced rent.

(e) Employees who are eligible for Rent Free Quarters under relevant rules, and who have not been provided with such quarters shall be eligible

for Additional House Rent Allowance at 8% of pay subject to a maximum of Rs. 150/- pm.

(f) Pay for the purpose of calculation of House Rent Allowance under this order shall be the pay as defined under FR 9 (21) (a) (i).

(g) Separate orders will be issued revising the rates of rent for the Government quarters provided to the Government employees.

(h) These orders shall also apply mutatis mutandis to all categories of personnel viz.,

Government employees, all employees of Zilla Praja Parishads, Mandal Praja Parishads, Grampanchayats and Municipalities. Zilla Grndhalaya Samsthas, Agricultural Market committees, Teaching and Non-teaching staff of Aided Institutions including Aided Polytechnics and Work-Charged Establishment who get monthly pay in the Revised Pay Scales, 1993.

4. These orders shall take effect from 1st January, 1993 with the monetary benefit from 1.4.1993.

5.1 The revised percentage rates of House Rent Allowance and Additional House Rent Allowance specified in para 3 above shall not be applicable to the following categories of employees:

(a) Those employees who opt to remain in the A.P. Revised Pay Scales, 1986.

(b) Teachers working in the University, affiliated degree colleges both under Government and aided managements who are drawing pay in the A.P. Revised UGC Pay Scales 1986.

(c) Officers belonging to All India Services.

5.2 The categories of employees specified in 5.1 above shall draw the allowances at the existing rates prescribed in the G.O.s 6th and 7th and Circular Memo 5th read above.

5.3 The category of employees specified in 5.1 above shall, however, be governed by the Note under para 3 (a) (i) (subject to 5.1 and 5.2 above) and also the provisions of para 3(b) 3(c) and 3(e) above. Note : The amount of House Rent Allowance already drawn on Special pay and Personal Pay after 1.1.1993. If any, by these categories of employees in pursuance of the earlier orders, shall not be recovered.

5.4 The employees of the categories 5.1 above, who are eligible for rent free quarters under relevant rules and who have not been provided with such quarters shall be eligible the Additional House Rent Allowance at the rate of 10% of the pay subject to a maximum of Rs. 150/- per month.

5.5. These orders shall not apply to the Police personnel of the rank of Inspectors and below for whom separate orders will be issued by the Home

- (a) for sub-rule (1) the following shall be substituted, namely:-  
"(1) Every Government employee shall be eligible to draw the Allowance at the rates specified in rule 2 as per his category and as per the place of duty referred to therein".
- (b) in sub-rule (2), for the expression, "10%", the expression, "8%", shall be substituted.
- (c) in sub-rule (3) for the expression, "10%", the expression, "8%", shall be substituted.
- IV. in sub-rules (5) and (6) of rule 6, after the expression, 'whose basic pay is Rs. 3,880 and below in the Revised pay Scales 1986', the expression, 'and whose basic pay is Rs. 6840 and below in the Revised pay Scales 1993', shall be inserted.
