ORDER: In the Government Order read above orders were issued inserting a sub-clause (iv) inclause (a) of rule 22 of the Fundamental Rules providing a benefit of fixation of pay of a regular Government employee (not appointed under the emergency provisions) when appointed directly to another post under the Government on selection by Andhra Pradesh Public Service Commission in the new post at a stage which is not lower than the pay drawn by him in the earlier post.

- In the Memo, second read above clarificatory instructions were issued allowing the fixation of pay on appointment to another post under Government service on selection by Andhra Pradesh Public Service Commission at the minimum of the scale attached to the new post. If the pay so fixed happens to be less than the pay drawn from the previous post then the short fall may be protected as personal pay to be absorbed in future increases in pay.
- Aggrieved by the above method of fixation as clarified in the Memo.2nd read above one of the employees has approached the Andhra Pradesh Administrative Tribunal in the year 1987 and filed R.P.NO.5132. The Tribunal in its Judgement dated 18.9.1988 in the said R.P.had observed that the Memo, second read above is only an executive order or an administrative proceedings and it cannot prevail over the statutory rule introduced through the Government Order first read above.
- The directions of Tribunal were examined in detail in consultation with Law Department. The government after careful examination has decided to bring the contents of the Memo.No.24555/FR.II/84-1, dated 5.10.1984 as a proviso to sub-clause (iv) in clause (a) and rule 22 of the Fundamental Rules with some modification. Accordingly, it has been decided to amend the Fundamental Rules suitably.
- The following notification will be published in the Andhra Pradesh gazette:

NOTIFICATION

In exercise of the powers conferred by sub-section (i) of section 3 of the Andhra Pradesh Public employment (Regulation of Conditions of Service) Ordinance, 1983 (Andhra Pradesh Ordinance No.5 of 1983), the Government of Andhra Pradesh hereby makes the following amendment to the Fundamental Rules:

AMENDMENT In rule 22 of the said rules, in clause (a), after sub-

clause (iv), the following proviso shall be added, namely:-"Provided that if there is no stage in the pay scale of the

new post, the pay shall be fixed in the new post at the stage next below the pay protecting the short fall, if any, as personal pay to be absorbed in future rise in pay on account of grant of increment of other-wise. Provided further that this benefit shall be confined to the Government employees only. The employees working in Cen-

tral Government, Universities, Aided Institutions etc., who are appointed to the Government service on selection by the Andhra Pradesh Public Service Commission or Dist. Selection Committee are not eligible for the benefit provided under subclause (iv) of this rule".

The pay under FR 22(a)(iv) to a regular Government Servant when appointed

directly to another post, under the Government on selection by APPSC shall be fixed in the new post at a stage which is not lower than the pay drawn by him in the earlier post.

It is noticed that some of the Departments i.e. Home Dept. and Education Depts have-done the pay fixation under FR-22(a)(iv) to certain Assistant Section Officers and also allowed the next increment with effect from the date of increment in their previous post.

Government have examined the matter and hereby clarify that protection of pay only is allowed in respect of fixation under the above rule, but there is no rule for protection of increment date in the previous post. All the Departments and Heads of Depts are requested to follow the above rule scrupulousity.

ORDER:

In the reference 1st read above, the A.P. Secretariat Association, Hyderabad has stated that certain employees have appeared for competitive examinations conducted by APPSC and got selection for different posts i.e., ASOs. in Secretariat, as Senior Accountants or equal cadres in the Directorates etc., in the Government service. Before entering into Government Service they had rendered long service in post falling under jurisdiction of local bodies. It has been represented that they were drawing much higher pay than the minimum of the time Scale of Pay in the present posts for which they are freshly recruited under Government service. After joining in the present Government posts they have not been allowed service benefits like pay protection, carry forward of leave and counting of past service for pension for the reason that they are not covered under FR 22(a)(iv). It has been represented that this refusal is causing much heart burning and hardship to employees who had worked earlier under local bodies and been recruited to the posts in the Government. It was further stated that all service conditions of the employees of local bodies and employees in Government are similar in nature and the services of the local bodies were provincialised in G.O.Ms.No. 168, P.R. (Estt.III) Dept., dt. 20-3-1981. As the salaries of the employees of local bodies are being drawn under the Head "010. Salaries' from out of the consolidated fund of the State, the Association requested to allow pay protection for all the employees recruited through APPSC irrespective of the post from which they came.

- 2. According to the orders issued in G.O. 2nd read above Govt. employees have been declared ineligible for direct recruitment. The said rule has been amended in G.O.3rd read above and Government permitted govt. employees to apply for direct recruitment and further Govt. employees have been permitted to retain all other benefits accrued to them in the previous posts except the lien. In G.O. 5th read above, orders have been issued for protection of pay stipulating that the pay in the new post should not be less than the pay drawn by the Government servant in their earlier post. In Memo. No. 24555/788/FR.II/84-1, dt. 5-10-1984 a clarification was issued to this G.O. stating that the pay may be fixed at the minimum of the scale of the new post, and if this pay happens to be less than the pay drawn from the previous post, then the shortfall in pay should be protected as personal pay to be absorbed in future increases. The sole ground on which these instructions were issued was that junior shall not draw higher pay than his seniors by virtue of his holding a post before selection by APPSC.
- 3. Consequently and in view of the judgement of Supreme Court orders were issued in G.O.6th read above providing for pay protection, which was confined to the government servants only. According to the said orders, "this benefit shall be confined to the Govt. employees only. The employees working in central Govt. Universities, aided Institutions etc., who are appointed to the Govt. service on selection by the A.P.P.S.C.. or Dist. Selection committee are not eligible for the benefit provided under sub-clause (iv).
- 4. According to Rule 39 © of A.P. State and Subordinate service rules, a person in the service of the government, who applies for direct recruitment and accepts the new post will retain all benefits accrued to him in the previous post except the lien which he has held over will come to an end.

- In the wake of orders mentioned above, the request of the A.P. Secretariat Association has been examined and the Government is of the view that as the word "provincialisation of services" is no where defined in the Acts or the Rules and as at present the salaries are being paid through Treasuries from 10-12-2004 under the Head of Account "010. Salaries" the benefit of this protection can be agreed to the employees who are appointed after . 10-12-2004.
- In the circumstances stated above, Government hereby order that the former 6. employees of local bodies who are appointed later through A.P.P.S.C. and D.S.C., in Govt. Service on or after 10-12-2004, and who are continuing in government service as on today be given pay protection under F.R 22(a) (iv) with monetary benefit from the date of issue of these orders.

The attention of all the District Educational Officers in the state is invited to the references goad above. They are informed that the process of Recruitment of Teachers to various category of the posts under TET cum TRT-2014 is almost completed.

It is observed that certain candidates are waiting for posting orders in view of delay of verification of certificates. Hence, the following instructions are issued:

- a) There are 966 candidates who are selected but waiting for posting orders for want of confirmation of genuineness of certificates under PH category especially flearing Impaired should be posted against the left over vacancies with the prior approval of the DSC 2014.
- b) In respect of those candidates, who did not exercise the web options/did not receive OTP on the date specified, the posting orders should be issued against the left over vacancies with the prior approval of DSC 2014.
- e) Vacancies if any left over, after issue of the above posting orders shall be carried forward and there shall be no waiting list.
- d) Formsh the final selection list of all category of the posts to this office in hard/soft copies with the approval of the DSC,2014 immediately.
- el The final selection list furnished by the District Educational
 Officers shall be hasted on CSE Portal www.cse.ap.gov.in No

f) The final selection list should be published on 30.06.2016

Utilization of Services of Teachers under DEO's Pool :

There are 966 candidates who are selected in TET cum TRT 2014 and allotted to DEO's pool in 4 districts. The services of such candidates may be utilised as here under:

- 1. If any vacancy is available in agency area, the surplus teacher (DEO's pool) may be accommodated on work adjustment basis temporarily in order to provide qualitative and quantitative education to the agency children, till a regular teacher is posted. This adjustment should be done with the prior approval of DSC 2011.
- 2. The surplus teacher may be utilized for temporary work adjustment replacement teachers in place of regular teachers who proceeded an over 1 week medical leave, long leave (Study Leave; abroast travel, etc.) EOL Maternity Leave, etc.
- The surplus teacher may be adjusted against need based vacancy in UPS/HS based on the qualification.
- The surplus trachers may be utilized for imparting rentedial coaching as part of School Readiness Programme of SCERT.
- 5. The services of surplus teachers may be utilised for identification of dropouts, school aged children, not enrolled, recognising duplicate Aadhar Cases in Child Info, etc. in the district

The District Educational Officers are further informed that the teachers who are already working and appointed in TET cum TRT 2014 should be reachers as per rules and climbility.

Hence, all the District Educational Officers in the State is requested to take necessary action accordingly.
