During the management committee meeting held on dated: 15.03.2021 under the chairmanship of CEO, Dr. YSR Aarogyasri Health Care Trust some of the members have requested to send clarification to commissioner of School Education Department regarding:

- a) Acceptance of treatment of the employees of Chittoor, Ananthapur & Nellore Districts. As per G.O.Ms.No. 159 HM & FW (I.1) Department, dated: 22.12.2014
- b) Acceptance of Medical Reimbursement bills of Employees & Pensioners of School Education Department in case if they get treatment in non-referral hospitals.

Dr. YSR Aarogyasri Health Care Trust has thoroughly examined the request made by the members of Management Committee and representation by MLC, Shaik Sabjee vide Lr. No. 5/2021, dated: 06.04.2021. In regard to (a), it is to note that vide G.O.Ms.No. 159 HM & FW (I.1) Department, dated: 22.12.2014 in para 3 clause VII & VIII, the Government clearly says as follows:

"VII. Even in the case of employees/pensioners who are having "Health Cards" if they avail treatment in Non-empanelled hospitals, in Emergency, they may be allowed reimbursement, as per the package rates of Employees Health Scheme.

VIII. Employees working in Nellore, Chittoor & Ananthapur having health cards, and seek treatment in the Super Speciality Hospitals in Chennai, Vellore & Bengaluru respectively, especially in case of complicated diseases will be allowed reimbursement as per the package rates of Employee Health Scheme".

The above guideline is followed by all the departments with regard non referral hospitals, hence same also may be followed by school education department.


In regard to point (b), Dr. YSR Aarogyasri Health Care Trust has been following guidelines and instructions laid down in G.O.Ms.No.68 HM & FW (K1) Dept. dt.28-03-2011 under para 2 in clause j):

"j. The treatment of all accident cases and all emergent cases in the Unrecognised Private Hospitals is permitted".

The above guideline is followed by all the departments with regard non referral hospitals, hence same also may be followed by school education department.

Mr. Shaik. Sabjee, MLC has requested clarification applicability of Medical reimbursement for COVID-19 treatment in Non-referral Hospitals. In this regard, As per G.O.Rt. No. 30 HM & FW (I.1) Department, dated: 29.01.2021 treatment of COVID-19 under Medical Reimbursement scheme within the state and outside the state i.e., Hyderabad, Bengaluru & Chennai subject to ceiling amount upto 2 lakhs.

ORDER:

Whereas, the state is threatened by spread of Covid-19 virus disease, the WHO has declared as pandemic, in exercise of the powers contained u/s 65 of AP Epidemic Disease (Covid) Regulations, 2020 respectively; Govt. of Andhra Pradesh has issued directive measures to be taken by Collectors, Joint Collectors, Municipal Commissioners for containment of COVID-19. There is an imminent need of quick expansion of medical facilities in the district of **GUNTUR** for isolation rooms, isolation beds, ventilators, other medical facilities, infrastructure, material, manpower including doctors, nurses and other medical & non medical staff. Therefore, private medical college attached hospitals & other private hospitals Aarogyasri and Non-Aarogyasri Hospitals in the district are required for their services to be used for Covid 19 treatment.

The Government vide G.O.Ms.No.77 and 78, dated 08.07.2020 & 20.07.2020 of Health, Medical & Family Welfare (I) Department, Govt. of A.P. (in the reference 4th cited) illustrated various tariffs of various category of patients for treatment in private hospitals (copy enclosed G.O.Ms.No.77). It is to inform that as per the G.O.Ms.No.77, if any hospital having more than 70 beds capacity with all facility may apply to the District Collector, Guntur for permission to treat the COVID 19 positive patients in their hospital as per the tariffs specified in G.O.Ms. No.77 and admitted the injections detailed in G.O.Ms. No.78 also.

In the reference 6th cited, **Vikasa Hospital, Piduguralla** submitted proposal for issue of permission for treatment of Covid patients.

Hence, the Management of the **Vikasa Hospital, Piduguralla** is hereby directed to start treatment of tested positive patients within 48 hours without fail.

:: 2 ::

- (1) Cases shall be admitted on the reference of the DM&HO, Guntur or any authorized Medical Officer only
- (2) Admissions of unauthorized persons are strictly prohibited.
- (3) The Management shall not collect over and above the tariffs/rates Communicated in the G.O.M.S. No.77, dated 08.07.2020 & G.O.Ms.No.77 dated 20.7.2020 of Health, Medical & Family Welfare (I) Department. It has to strictly implemented.
- (4) Advised to follow all Covid instant orders issued by the Government time to time for the triage of Covid 19 and non-Covid patients treatment protocol, discharge protocol and disposal of Dead Body protocol.
- (5) The Management shall arrange 3 Help Desk Managers/Volunteers for 24 hours in three shifts @ 8 hours duty per each person in shift in three shifts i.e. 6.00 a.m. to 2.00 p.m., 2.00 pm to 10.00 p.m. and 10.00 p.m. to 6.00 a.m. for a period of 4 months initially. The Management shall arrange a Help Desk, Beds availability display board, computer with printer and internet and two land line phones, CCTV arrangement covering all wards and help desk.
- (6) Salary to the three (3) Help Desk Managers/Volunteers will be paid by Government @ 8,000/- per month.
- (7) Hospital should arrange 3 representatives from the hospital side to work along with Help Desk Managers/Volunteers
- (8) 100% of the beds must fill with COVID-19 patients under Dr.YSR Aarogya Sri.
- (10) The hospital management should apply for login permission in MSS app for entering admission details, vital updations, discharge details & case sheets, etc.
- (11) Daily situation report shall be submitted in the proforma enclosed
- (12) Treatment Protocols and treatment procedure strictly as per the Govt guidelines
- (13) Hospital must send the report in every day (DSR) to Medical Management team
- (14) Vaccination should be conducted 100 per day.
- (15) Any complaints against hospitals directly from the patients or from IVRS survey conducted by CHFV will be considered seriously and action will be initiated.

Your are also advised to refer all Covid instant orders issued by the Government time to time for triage of Covid-19 and NON-COVID patients, treatment protocol, discharge protocol and disposal of Dead Body protocol, For any quarries regarding admission and treatment of Covid patient you may contact DM&HO, Guntur/Superintendent, GGH, Guntur.
