ORDER :

The Government have received representations for allowing State Govt. Employees to take extraordinary Leave with permission to take up employment abroad i.e. in foreign countries.

2. The Andhra Pradesh Non-Gazetted Officers association. Hyderabad has requested the Government to adopt the policy of the Government of Tamilnadu in permitting their employees to secure and accept jobs abroad on Extraordinary leave.

3. In the reference 3rd read above, Government have issued orders permitting the Docotors in the A.P. Medical and Health Service to go abroad for taking up employment/training for a maximum period of 4 years and 1 1 months subject to certain conditions.

4. In the context of acute pressure for Government employment and existence of surplus staff in some Departments it has been considered whether a liberal view may be taken in the matter so as to enable Government Servants to go abroad for gainful employment for specified periods.

1. Government employees desirous of seeking jobs abroad, irrespective of categories to which they belong technical, non-technical or clerical be permitted to apply and secure employment abroad without applying for voluntary retirement or resigning from service. However, such of thos scarce categories of staff/officers whose services are considered essential to this Government shall not be permitted to secure job abroad.
2. The period of absence during employment abroad will be treated as extraordinary leave without allowances but such period of absence will not be construed as a break in service. It will not be counted for service benefits such as increment, pay, leave etc However, if contribution towards pension is paid by the foreign employee such periods will count for pension.
3. That no Government dues are pending recovery from the Government Servant.

4. That no prosecution is pending or contemplated in the Court of Law against the Government Servant.
 5. If the absence of the employee exceeds five years he ceases to be a Government Servant.
 6. On return from leave the Government employee shall not claim any preference over others in their parent department for promotion or higher pay by virtue of the experience gained in foreign employment.
 7. All Government Servants may opt voluntarily to this scheme.
 8. There shall not be any compulsory element and Govt. Servants with 5 years regular service only shall be eligible to avail the scheme.
 9. The benefit of the scheme shall be given to Government Servants once in the entire service.
 10. The Government Servant should obtain specific permission from the Government before he undertakes any employment abroad.
 11. The scarce categories mentioned on item (1) shall be identified and a list shall be prepared and maintained by each Head of Department with the prior approval of the Government. The list shall be updated from time to time based on the emerging needs and experience.
6. A provision in the A.P. Civil Services (Conduct) Rules shall be introduced with regard to issue of 'No Objection Certificate' to obtain Passport for seeking employment abroad. Orders will be issued in this regard by the Government in the General Administration Department separately.

In the G.O. cited orders have been issued permitting Government employees desirous of
seeking employment abroad to apply and secure gainful employment abroad for a specified
period, subject to conditions stipulated therein.

2. It has been observed that when employees are applying for sanction fo leave for taking up
employment abroad or for permission to seek jobs abroad, the administrative Departments
are circulating such proposals for obtaining orders in circulation of C.M. through C.S. and
Minister (Finance). It is hereby 'clarified that all applications which fulfil the guidelines of the
G.O. can be approved by the Ministers concerned and that there is no need for such cases to
be circulated to Minister (Finance) and C.M. through C.S, Further in respect of proposals
where the conditions of the G.O. cited are satisfied, such cases need not be referred to the

Finance and Planning (FW.FR.I) Department unless any specific clarification is required.
3. The Government servants who are desirous of accepting employment abroad should obtain specific permission from the Government before they undertake any employment abroad in terms of para 5 (X) of G.O. cited, after receiving a specific offer from the foreign employer. It is, therefore, clarified that the intention of the orders issued in the G.O. cited is that the leave should not be utilised to secure job abroad, but should be utilised for undertaking employment abroad.

ORDER :

In the Government Order read above orders were issued permitting Government Servants, irrespective of categories to which they belong, to secure and accept jobs abroad subject however, to the conditions laid down in the said Government Order.

In Para 6 of the said Government Order it was indicated that a Provision in the Andhra Pradesh Civil Services (Conduct) Rules shall be introduced with regard to issue of 'No Objection Certificate' to obtain Passport for seeking employment abroad.

The matter has been examined in consultation with General Administration Department and it is felt that there is no need to amend the conduct rules and the Home (Passport) Department will issue guidelines for obtaining of 'No Objection Certificate to obtain Passport for seeking employment abroad.

Government therefore, hereby make the following amendment to Para 6 of the instructions issued in the Government Order read above.

"In the said orders issued in the Government Order read above, Para 6 shall be omitted".

The Government have had under examination the proposal to remove the condition of availing of the benefit of the scheme only once in the entire service as ordered in the reference 1st cited and read with the reference 2nd cited and permitting its use in different spells but subject to the condition of a maximum period of 5 years.

3. Government after careful examination hereby issue the following amendment to para 5 (ix) the G.O. 1st read above.

AMENDMENT

"The benefit of the scheme shall be given to Government employees at a single stretch or in different spells, but for a period not exceeding five years in all during the entire service"
