ORDERS:-

In the reference $4^{\rm th}$ read above orders were issued extending the benefit of encashment of Half Pay Leave to the State Government Employees as applicable to the Central Government Employees as per the reference $2^{\rm nd}$ and $3^{\rm rd}$ read above and based on the recommendations of High Power Committee constituted in the G.O. $1^{\rm st}$ read above.

2. In the Government Order 6th read above, orders were issued constituting Ninth Pay Revision Commission and Government appointed Sri. C.S. Rao, IAS, (Retd) as Pay Revision Commissioner. In the Government Order 7th read above, the terms of reference of the Pay Revision Commissioner were laid down.

- 3. The Ninth Pay Revision Commission submitted its report to the Government on 05.12.2009 and recommended, inter alia, that, "The Commission after examining the above requests recommends to adopt the same formula in the case of encashment of Leave on Half Pay at the time of retirement / death in the case of State Employees also subject to the condition that the total number of days of earned leave + leave on half pay put together should not exceed 300 days for encashment".
- 4. It is observed in the report that as per the existing orders, the cash equivalent of leave salary on account of encashment of leave on half pay shall be calculated in the manner indicated below.

- 5. The above formula was adopted based on the orders issued by Government of India to its employees.
- 6. Based on the recommendations of 6th CPC, the Government of India issued revised orders changing the formula in the following manner- (vide O.M.No.14028/3/2008- Estt. (L) dated: 25-09-08 of Department of Personnel & Training Ministry of P.PG & Pension, Government of India, 5th read above).

7. The Employees' Associations requested to adopt the above formula in the case of encashment of L.H.P. of the State Government employees and the Commission after examining the above requests recommends to adopt the same formula in the case of encashment of Leave on Half Pay at the time of retirement / death in the case of State Employees also subject to the condition that the total number of days of earned leave + leave on half pay put together should not exceed 300 days for encashment.

8. After careful consideration of the report, Government decided to accept the recommendations of the Pay Revision Commissioner and hereby order that formula for calculation of encashment of Leave on Half Pay at the time of retirement / death in the case of State Employees shall be as follows subject to the condition that the total number of days of earned leave + leave on half pay put together should not exceed 300 days for encashment.

I wish to submit that encashment of Half Pay Leave at the time of retirement of Government Employees are issued by the Government vide references 1st, 2nd and 5th cited. In the reference 8th cited Government have issued clarification stating that the above orders are applicable to the Government Employees only and not applicable to the Panchayat Raj and Municipal Institutions, if the above orders are not extended to them. In this connection I am to state that all the Government orders are directly extended to Government Employees only and the orders issued by the Government from time to time are extended to the Local Body Employees as well as Municipalities. In the same analogy there is no mention about the extension of the following HPL Government Orders to the Panchayat Raj Teachers, Municipal Teachers including non-teaching staff. The President, P.R.T.U., A.P., Hyderabad and other Teacher Associations represented that the following G.Os. may be extended to them, so as to enable to utilise the facility accorded by the

- 1. G.O.Ms.No. 342, dated 30.09.1994.
- G.O.Ms.No. 234, dated 27.10.1999.
- 3. G.O.Ms.No. 154, dated 04.05.2010.

extend the benefits ordered in G.O.Ms.No. 154, Finance (FR-I) Department, dated 04.05.2010 with regard to Half Pay Leave to the Panchayat Raj Teachers

The employees of Local Bodies/Municipal are enjoying the same benefits on par with Government Employees on the following except encashment of Half Pay Leave at the time of Retirement.

- Revised Pay Scales.
- Annual Grade Increments.
- 3. Salaries.
 - 4. Pay Protection. In the International Inte
 - 5. Leave Rules and Pension Rules.
 - Encashment of EL.

A comparative statement is also enclosed for ready reference.

In view of the above, I request the Government kindly to re-examine the issue of extending the benefits of encashment of Half Pay Leave on retirement to the teachers of Mandal Parishad/Zilla Parishad/Municipal Managements.

Brief notes on benefits given to the Panchayat Raj Teacher as well as Government Teachers:

- It is submitted that the Teachers are working under two managements in Education Department i.e.,
 - 1) Panchayat Raj Teachers
 - 2) Government Teachers.
- Earlier the C.E.O. is the appointing authority for the teachers working under Panchayat Raj Department and the District Educational Officer is a competent authority for the teachers working in the Government Department.
- The Panchayat Raj teachers were provincilised by the Government and extended all the benefits to the Panchayat Raj Teachers on par with Govt. Teachers as follows.
- Now, the appointing authority for Panchayat Raj Teachers and Government Teachers is District Educational Officer as per Service Rules

The attention of the Commissioner & Director of School Education, Hyderabad is invited to the references cited. The Teacher Associations have been contending in the matter that since 1994 the Panchayatraj Teachers have utilized the benefi of H.P.L. encashment at the time of retirement. But this facility has been stopped/denied because of the clarification issued in Memo No. 7380/PE-SERVICES-I/2012, Education(PC)Department Dt. 10.12.2012. In this regard, it may be observed that there has always been some kind of inconsistency on the applicability of this benefit for Panchayatraj Teachers. The Director of Local Fund Audit A.P. Hyderabad had addressed letters to Government vide his letter dated 6.11.1997, 5.11.1999 and 25.11.1999 seeking clarification on the applicability of this provision to the local body employees etc. Further, while provincialising the Services of employees of Panchayatraj Institutions vide G.O.Ms.No.168,PR&RD (Estt-3) Dt:20.3.1981 it has been mentioned therein that till such time separate orders regarding amendment to service rules issued their salaries and allowances from existing sources should continue. Accordingly, separate orders have been issued in G.O.Ms No. 354, PR&RD Accounts-II Department, Dt. 16.9.2008 for drawl of their salaries through the Head of Account "010". But it is not known whether any such order have been issued either by the P.R. Department or School such as Half pay Leave Education Department in respect of allowances encashment at the time of retirement. It is also not known from the report of the Commissioner & Director of School Education, Hyderabad in letter Dt. 13.10.2013, about the previous practice in this regard while the PR. Teachers were under the Administrative Control of PR&RD Department/ Zilla perished.



Therefore, the Commissioner & Director of School Education, Hyderabad is requested to examine what has been the previous entitlement given for Panchayatraj Teachers in respect of enhancement of Half Pay Leave at the time of retirement while they were under the control of P.R. Department and subsequently till the issuance of the subject clarification in the Memo.Dt:10.12.2012 above cited. She is further requested to thoroughly examine the entire issue, and submit a detailed report to Government for taking necessary action in the matter.

In response to the Govt. Memo 10th cited, I submit that, It is not known whether any entitlement given by the Panchayat Raj Department to the Panchayat Raj teachers previously in respect of encashment of Half Pay Leave at the time of retirement while they were under the control of Panchayat Raj department. Further, subsequently no orders have been issued from this office till the issuance of clarification issued by the Government in their Memo, dated: 10-12-2012.

Further, I wish to submit that, the Government vide reference 1st, 2nd and 5th cited have issued orders for encashment of Half Pay Leave at the time of retirement to the Government Employees only, which were not extended to the Local Bodies / Panchayat Raj / Municipal managements. Therefore, certain teacher associations have made representations for extending encashment of Half Pay Leave at time of retirement to the Local Bodies / Panchayat Raj / Municipal managements also.

In this regard, a detail report has already been submitted vide reference 9th cited.

In view of the above, I request the Government kindly to re-examine the issue of extending the benefits of encashment of Half Pay Leave on retirement to the teachers of Local Bodies / Panchayat Raj / Municipal managements and issue necessary orders at an early date in the matter.

In their letter first cited, the Director of Treasuries and Accounts, AP, Hyderabad has informed that the Accountant General (A&E), Andhra Pradesh, Hyderabad has pointed out that the treasuries are classifying the leave encashment benefits of the retiring employees under sub detailed head 010 -Salaries 018- Encashment of earned leave of respective reverue head instead of MH 2071- Pensions and other Retirement Benefits 01- Civil 115- Leave Encashment Benefits.

- As per the provisions made in the Budget of Andhra Pridesh State for the payment of Leave Encashment Benefits of the retiring Employees is under MH 2071- Pensions and other Retirement Benefits 01- Civil 115- Leave Encashment Benefits.
- Therefore, the DTA, AP, Hyderabad requested the Government for incorporating the Head of Account MH 20/1- Pensions and other Retirement Benefits 01- Civil 115- Leave Encashment Benefits in the BE 2016-17 as per the details mentioned in Appendix XI of AP Budget manual, so that the leave encashment benefits granted at the time of retirement/termination of service etc., shall be classified accordingly.
- Government after careful examination of the matter, hereby instruct all the Sanctioning Authorities and all the Drawing and Disbursing Officers to book the expenditure related to leave encashment benefits granted at the time of retirement under the following Head of account:

- 7. The yearly surrender leave encashment may however be classified under 010-018 as per the existing procedure.
- 8. Therefore, all the Secretariat Departments, HODs and Director of Treasuries and Accounts, AP, Hyderabad are requested to issue suitable instructions to all DDOs working under their control to book the extenditure related to Leave Encashment benefit granted to the retired employees as shown at paras 4&5 above.

ORDER:-

In the reference read above, orders were issued adopting the formula for calculation of encashment of Leave on Half Pay at the time of retirement / death in the case of State Employees subject to the condition that the total number of days of earned leave + leave on half pay put together should not exceed 300 days for encashment as indicated below.

Cash payment in lieu of half pay leave component	=	retirement plus D.A.	x	No. of days of half pay leave at credit subject to the total of earned leave and half pay leave at credit not exceeding 300

2. Several representations from the Employees' Associations have been received to extend orders issued in the reference read above to the teachers working in aided institutions and local bodies. The Pay Revision Commission 2010 of Government of Andhra Pradesh has also recommended to extend facility of encashment of Earned Leave, including the Half Pay Leave upto a maximum of 300 days to them also.

- 3. After careful examination of the matter, Government hereby order to extend the orders issued in the reference read above to the teachers working in the Municipal, Panchayat Raj and Aided schools on par with the Government employees.

ORDER:

Government of India vide Office Memorandum 14020/1/90-Estt. (L) dated 6.4.1993, Department of Personnel & Training allowed encashment of Half Pay Leave at the credit of Government servants who retire on superannuation subject to the condition that pension and pension equivalent of other retirement benefits be deducted from the amount payable as cash equivalent. The State Government in pursuance of the recommendations of the High Power Committee extended the benefit of encashment of Half Pay Leave at the credit of State Government employee on retirement as applicable to Central Government employees.

- 2. Based on the recommendations of 6th CPC, the Government of India issued revised orders changing the formula vide O.M.No.14028/3/2008 Estt. (L) dated: 25th September, 2008. The Ninth Pay Revision Commission recommended to adopt the same formula in the case of encashment of leave also subject to the condition that the total number of days of earned leave + leave on half pay put together should not exceed 300 days for encashment. Accordingly orders were issued in G.O.Ms.No154, Finance(F.R.I) Department, dated:04.05.2010.
- 3. On the reference from the Director of School Education, a clarification was issued vide Memo No. 7380/PE. Ser I/2012 dated 10.12.2012 that orders issued in G.O.Ms.No.154, Finance(F.R.I) Department, dated 04.05.2010 are applicable to the Government employees and not applicable to the employees of the Panchayat Raj and Municipal institutions. It led to large number of teachers approaching to the Hon'ble APAT.

- 4. The Tenth Pay Revision Commission recommended to extend the facility of encashment of Earned Leave, including the Half Pay Leave up to a maximum of 300 days to all the employees, teaching as well as non-teaching staff of aided institutions and local bodies i.e., Aided Junior Colleges/Degree Colleges/Oriental Colleges and also for teaching and non-teaching staff of Aided Schools and the employees of Panchayat Raj and Municipal institutions.
- 5. The Hon'ble APAT allowed the OA No. 6775/2014 on 31.12.2015 with the following observations :

"This Court had an occasion to deal with the issue whether the employees including teachers of the Panchayat Raj & Municipal Institutions, ZP and MP Institutions are Govt. Servants or not and it was held by this court in OA No.1668/2015 and batch dt:15.12.2015 that the employees including teachers of the Panchayat Raj & Municipal institutions are government servants. So, in view of the same, the said issue is held in favour of the applicant in the present case also and consequently the Impugned Govt. Memo No.7380/PE- Ser.I / 2012, dated 10-12-2012 Education (P.E.) Department is set aside and the respondents are directed to allow the applicant to encash the half pay leave in terms of G.O.Ms. No. 154 Finance (F.R.-I) Department, dated: 4-5-2010 with all consequential benefits".

- 6. Accordingly, orders were issued in the references second read above, extending the orders issued in the reference first read above to the teaching and non-teaching staff working in the Municipal, Panchayat Raj and Aided Institutions on par with the Government employees. In the reference third read above, the same facility was extended to the teaching and non-teaching staff of Aided Junior Colleges/Degree Colleges/Oriental Colleges and also for non-teaching staff of PR, Municipality and Aided Schools on par with the Government employees.
- 7. Several court cases have been filed and they were allowed on the analogy of the above directions of the Hon'ble A.P. Administrative Tribunal. Several representations have been received and Hon'ble Members of A.P.Legislative Council particularly the teachers' representatives raised the issue and requested the Government to implement the orders of Hon'ble APAT with retrospective effect i.e. from the date of issue of orders in the reference first cited.
- 8. Government after careful examination of the matter and keeping in view that homogeneous group of employees cannot be discriminated, in suppression of the orders issued in GO third read above hereby order that the orders issued in the reference first read above be extended to the teaching and non-teaching staff working in the Aided Junior Colleges / Degree Colleges / Oriental Colleges and also for teaching and non-teaching staff working in PR, Municipality and Aided Schools with effect from 4.05.2010.
