He / she shall work under the general supervision of the Headmaster / Mandal Educational Officer as the case may be during the period of apprentice. He / she shall be paid a monthly stipend at the rate to be prescribed from time to time by the Government. On satisfactory completion of the period of apprentice, he / she shall be appointed to a regular post with a regular scale of pay. It was also ordered therein that the apprentice period shall be counted for Probation.

3. In G.O. 2<sup>nd</sup> read above, orders were issued to the effect that the apprentice period of two years rendered by the teachers shall count for the purpose of sanction of 8 years / 16 years / 24 years Automatic Advancement Scheme.

4. Government have now examined the request of Teachers and their representatives for sanction of two (2) Notional Increments for the apprentice period of teachers and Government hereby direct that the period of apprenticeship of two years of the teachers be counted for the purpose of sanction of notional increments and to sanction two (2) notional increments w.e.f. 01.04.2009, but credited to the G.P.F Accounts only after 01.04.2010 and then onwards they will be added to their salary.

5. The Director of School Education, Hyderabad is requested to take necessary action accordingly.


i) No. Modifications are required for the G.O.Ms. No.2. Education (SE-Ser.III) Dept. dated 02.1.2009 as proposed by the Associations.

ii) Regarding extension of orders issued in G.O.Ms.2, Education (SE-Ser.III) Dept., dated: 05-01-2009, the Associations may approach the M.A&U.D Dept., in case of Municipal Teachers and T.W. Dept in S.W. Dept. for the teachers working in the Tribal Welfare Management Schools.

iii) Since in the aided schools aid is being paid on the basis of sanctioned post and not on the basis of the teachers working in the post, the request for sanction notional increments to aided school teachers connote be complied with.

iv) the method of recruitment of Special Teachers and Apprentice Teachers appointed during and after 1994 is different and the apprentice teachers are fully qualified to hold the post and they are appointed in regular vacancies at the time of appointment whereas the special teachers are appointed without regular vacancies at the time of the their appointment and most of them are not qualified at the time of their appointment and they were absorbed if fully qualified, as and when vacancies arise. Therefore the special teachers have no claim for sanction of notional increments on par with apprentice teachers as requested for by the associations.

3. The Commr. & Dir. Of School Education, A.P., Hyderabad, shall take further necessary action accordingly on the representations cited in the ref. Cited under intimation to Government.

In the G.O. 1<sup>st</sup> cited, orders have been issued to count the period of apprenticeship of two years of the teachers for the purpose of sanction of notional increments and to sanction two (2) Notional Increments w.e.f. 01.04.2009 and credited to the G.P.F. Accounts only, after 01.04.2010 and then onwards they will be added to their salary.

2. In the reference  $2^{nd}$  cited, the Director of Treasuries and Accounts, Andhra Pradesh, Hyderabad has informed that the Deputy Directors of District Treasuries have sought for clarification on the sanction of Notional Increments for the apprentice period of Teachers and payment of arrears. He has stated that the above orders can be viewed in two different ways –

- (i) the minimum of time scale is notionally given from the date of appointment of the employee subsequent to 1994. Later notional increments are given year after year;
- (ii) the minimum of the time scale is not given to the individual as on the date of appointment. Instead two increments are sanctioned to the employee as on 01.04.2009.
- 3. Government after careful examination of the issue, it is clarified as follows:
  - (i) The period of two years apprenticeship of the teachers be counted for the purpose of sanction of two (2) Notional Increments in the regular scale of pay on completion of the apprentice period and on assigning the Pay Scale.
  - (ii) The fixation of pay shall be done notionally on completion of the two years apprenticeship period and on assigning the Pay Scale from time to time upto 01.04.2009;
  - (iii) Consequent on notional fixation, the monetary benefit shall be given from 01.04.2009 only;
  - (iv) The arrears from 01.04.2009 to 31.03.2010 shall be credited to the G.P.F. Accounts of the individuals in respect of the employees appointed before 01.09.2004 and 10% of basic pay and DA on the arrears shall be credited to the Contributory Pension Scheme in respect of the Teachers appointed on or after 01.09.2004 and the balance of arrears shall be credited to the Compulsory Savings Scheme;

(v) The fixation benefit w.e.f. 01.04.2010 shall be given in cash by adding the same in the salary for the month of April, 2010, payable on 1<sup>st</sup> May, 2010.

4. The Commissioner and Director of School Education, Andhra Pradesh, Hyderabad is requested to communicate these instructions to all the Regional Joint Directors, District Educational Officers in the State for taking necessary action accordingly.

5. The Director of Treasuries and Accounts, Andhra Pradesh, Hyderabad is requested to communicate the above clarification to all the Deputy Directors of District Treasuries in the State and issue instructions to admit the claims of teachers without any further delay.

In the G.O. 1<sup>st</sup> read above, Government have permitted to engage the selected (untrained) candidates of DSC 2002 as Special Vidya Volunteers and enroll them in a Special Training Programme commencing from March 2003 on monthly stipend of Rs.1000/- and the candidates so selected shall be directed for practical training by the DEO on merit-cum-choice basis and shall undertake project and course work as may be prescribed for becoming eligible to be appointed as Teachers.

Subsequently, on the representation of Special Vidya Volunteers belonging to SC/ST/BC/PH categories, in the G.O. 2<sup>nd</sup> read above, Government have enhanced the amount of monthly stipend from Rs.1000/- to Rs.1500/- per month during the second year starting from April 2004 and the training period of Spl. Vidya Volunteers will be construed as apprenticeship period and regular scale shall be paid as soon as the candidates successfully complete the training programme.

3. In the G.O. 3<sup>rd</sup> read above, Government have permitted the Director of School Education, to appoint the Special Vidya Volunteers as teachers on regular scale of pay with prospective effect from the date of issue of the said G.O. by relaxing the need for selection through DSC as they were already selected in DSC 2002.

In the G.O. 4<sup>th</sup> read above, Government have issued orders to count the period of 4 apprenticeship of two years of the teachers who were appointed as apprentice from 1994 onwards in Government/ZPP/MPP Schools for purpose of sanction of notional increments and to sanction two (2) notional increments with effect from 01.04.2009 and credited to the G.P.F. Accounts only after 01.04.2010 and then onwards they will be added to their salary.

On satisfactory completion of the period of apprentice, he / she shall be appointed to a regular post with a regular scale of pay. It was also ordered therein that the apprentice period shall be counted for probation.

2. In the G.O. 2<sup>nd</sup> read above, Government in School Education, had sanctioned (2) Notional Increments to the apprentice period to the teachers working in Government / ZPP / MPP Schools and directed to count the period of 2 years apprentice period for the purpose of sanction of 2 notional increments w.e.f.01-04-2009. Further, Government in Memo.No.8663/ Ser.1/2010, School Edn. (SE.SER-I) Dept., dt.01-07-2010, on the clarification sought by the Director of Treasuries & Accounts, Hyderabad have clarified the above issue including payment of arrears in respect of sanction of 2 notional increments.

3. In GO 223 (EducationSer.III-2) Dept., dt.01-07-1989, Government have relaxed the TTC qualification in favour of SC, ST candidates for recruitment to the post of SGT /Spl. Teacher and in pursuance of the said GO.223 (Education Ser.III-2) Dept., dt.01-07-1989, Education Department have issued instructions in Memo.No.79/Ser.III.1/ 2001-9, dt.31-07-2003, while drawing the attention of Director State Audit, Hyd., that such SC/ST candidates are entitled for Notional Increments from the date of their appointment as SGT till they acquire TTC qualification and monitory benefit will be allowed from the day of following the last day of acquiring TTC qualification.

4. In this connection, the Commissioner of Tribal Welfare, Hyderabad in the letter 4<sup>th</sup> read above, has stated that in representations dated 3-7-2010 & 5.8.2010, the Teachers Associations of Tribal Welfare have represented that the Notional Increments are not being released to the teachers working in Tribal Welfare Department by the District Treasury Officers with a plea that they have not received any instructions from the Director of Treasuries and Accounts, Hyderabad.

5. Further, the Commissioner of Tribal Welfare, Hyderabad has informed that in the Memo.No.1656/KK1/68-2, Edn. Dated.25/06/1968, Government have issued orders that "General orders applicable to the schools and teachers working in schools under different managements shall also apply to the schools and teachers under the control of the Director of Tribal Welfare and Director of Social Welfare also".

6. In the reference 5<sup>th</sup> read above, the Commissioner of Tribal Welfare, Hyderabad, has furnished the requirement of financial implications and budget provisions for sanction of notional increments of apprentice period of teachers as Rs. **3,10,44,036/-** and stated that the said expenditure will be incurred under the following head of account:

7. Further, the Commissioner of Tribal Welfare, Hyderabad has stated that there are (13) O.As filed by teachers of GPS (Tribal Welfare), Srikakulam District in Hon'ble Andhra Pradesh Administrative Tribunal for sanction of increments thereof and for payment of salaries from December 1991 to May 1993. The Hon'ble Andhra Pradesh Administrative Tribunal admitted the above OAs on 21-12-2010 and granted interim orders directing the 2<sup>nd</sup> Respondent (Commissioner of Tribal Welfare, Hyderabad) to pass orders on the letter of Project Officers, ITDA, Seethampeta, Srikakulam, District in Rc.No.K3/2003/Dy.E.O/F/Den. Dated 15.03.2010, where in the Project Officer, ITDA., Seethampeta has requested to issue instructions for sanction of increments to the teachers appointed on consolidated pay during the year 1991.

8. In view of the above, the Commissioner of Tribal Welfare, Hyderabad has requested the Government to issue necessary orders in the matter.

9. Government after careful examination of the matter hereby orders for release of (2) notional increments to the teachers working in Tribal Welfare Educational Institutions on par with the teachers working in Government/ZPP/MPP Schools who were sanctioned (2) notional increments with effect from 01-04-2009 based on the G.O.Ms.No.2, Edn. (Ser.III) Department, dated:05.01.2009.

10. The Commissioner of Tribal Welfare, Hyderabad is requested to take necessary action accordingly.
