Your attention is drawn to the ref cited: As verified the G.O.Ms.No. 95 Education (Ser. I) Dept. dt: 25-7-2005, it is learnt that those who were crossed 45 years of age are exempted from passing the departmental tests and another exemption is that those who were crossed 50 years of age are exempted from passing the departmental tests for promotions. These two rules are contradictory with each other.

(1) If any individual crossed 45 years of age he will be exempted from passing

the departmental tests for promotion only once in entire service.

(2) If any individual crossed 50 years of age he will be exempted from passing

the departmental exams if he promoted.

This shows two chances are given to each individual instead of one chance in entire service. Further Dy. Director, Dist. Treasury; Krishna raised an objection that the requisite qualification to hold 16 / 24 years scales under Automatic Advancement Scheme inevitable as per the continuation of G.O.Ms.No. 241, Finance (PC.II) Department, dated: 28-9-2005. The individuals those who crossed 45 years & 50 years are exempted passing the departmental tests. But the same exemption are not attributable to Automatic Advance Scheme and the age is not the criteria in awarding the 8 years, 16 years and 24 years but only incremental service, where as in regular promotions, age is criteria for relaxation or exemptions as the case may be. The two cases i.e. promotion and Automatic Advancement Scheme are entirely different and the clarifications given on one, cannot be applicable to another. Hence the objections raised by the Dy. Director, Dist. Treasury, Krishna is holds good

Kind attention is invited to the references cited above.

The G.O. at reference 1st cited deals with Educational Service Rules and in para 10(iii) & (iv) of the G.O. speaks about the exemption regarding the Departmental Tests prescribed in Service Rules after crossing the age limit at follows:

Para 10(iii) 'All persons who have crossed 45 years of age shall be exempted

from passing Departmental Tests for promotion to the next higher category above to the one held by her / him. This benefit is extended to ensure that every employee gets at least one promotion during his entire service. This exemption shall be given only once in the entire service".

Para 10 (iv) "All persons who have completed age of 50 years on the date of appointment to any post shall be exempted from passing the Tests referred to in Column

(3)".

In this regard it is submitted that as pointed out by the Deputy Director of Distrig Treasury, Krishna, some of the Teachers are claiming SPP Scale - II on completion of 24 years of service without acquiring requisite qualifications for the 2nd level promotion duly availing the exemptions under the provisions of para 10 (iii) and 10 (iv) of the G.O.Ms.No. 95. Education (Ser.I) Dept., dt : 25-7-2005.

In this regard vide letter No. M1 / 3309 / 2008, dt : 5-5-2008 (c.e.) the Director of Treasuries and Accounts has issued clarification that the exemption given to the individuals who have crossed 45 / 50 years of age for promotion in service is not applicable to Automatic Advancement Scheme. The two cases i.e., Promotion and Automatic Advancement Scheme are entirely different and the exemption given for appointment for regular promotion cannot be made applicable to appointment to SPP - I / SPP - II Scales. As per the provisions of G.O.Ms.No. 241, Finance (PC-II) Dept. dt: 28-9-2005, the individual should be fully qualified to hold the 1st or 2nd level promotion post as the case may be, to be eligible for appointment under Automatic Advancement Scheme

In response to the clarification at pre para Progressive Recognised Teachers Union A.P. & Andhra Pradesh Teachers Federation vide their representations dt : 1-07-2008 & 9-7-2008 (c.e.) have requested to reconsider for extending the of exemption of passing of tests who have crossed 50 years of age for the purpose of appointment to SPP-I / SPP - II Scales as is done in the case of regular promotion (under the provisions of G.O. 95 Education (Ser. I) Dept., dt: 25-7-2005).

The two exemptions mentioned at Para 10 (iii) and (iv) in G.O.Ms.No. 95 Education Department are not clear and appear to contradict each other. In the circumstances explained above, it is requested to clarify whether Teachers are eligible for appointment to SPP-I & SPP - II scales duly exempting them from passing departmental tests as they have crossed 45 & 50 years of age as mentioned at para 10(iii) and 10(iv) of G.O. cited in the first reference. An early clarification is requested in this regard.

Whether the Educational Service Rules issued vide G.O.Ms.No. 95, Edn. (Ser.I) Deptt., dated: 25-7-05 and G.O.Ms.No. 96, Edn., (Ser. II) Deptt., dated: 25-7-05 are in force, if not, which service rules may be considered for sanction of Special Promotion post Scale - I & II under AA Scheme.

The para 10(iii) of G.O.Ms.No. 95, Edn., (Ser. I) Deptt., dated: 25-7-05 related to exemption for passing the department test to those who have crossed 45 years of age is hold good, but the sub para (iv) of para 10 i.e., All persons who have completed age of 50 years on the date of appointment to any post shall be exempted from passing the tests referred to in column (3) "is contratry to each other. Hence he is requested to clarify the same.

Regarding to Language Pandits, what are the rerequisite qualifications and tests for promotion from Grade II to Language Pandists to grade I and whether the Language Pandits to Grade I and whether the Language pandits are eligible for promotion to Gazetted Head MasterPost (High School HM) and Deputy Educational Officer as per the existing service rules and orders.

In the Government Order 1st cited above, orders were issued introducing Automatic Advancement Scheme from 1-4-1981 to the Government employees with effect from 1-4-1981. In the Government Order 2nd cited above, the Automatic Advancement Scheme was Extended to the Teachers working in the of Government Schools, Municipalities, Municipal Corporations, Zilla Parishad and Panchayat Raj and also aided Managements.

2. As per the recommendations of Pay Revision Commission - 1999 modified Automatic Advancement Scheme orders were issued in the reference 4th cited. As per these orders the employees on completion of 45 years of age are to be exempted from passing the Departmental Test as prescribed in the Service Rules to get normal promotion, and also for appointment to Special Promotion Posts, subject to the conditions as laid down vide Government orders 3rd cited above.

3. Terms and conditions of G.O.Ms.No. 225 General Administration (Ser.C) Department are as follows.

1) The Government employees who have crossed 45 (forty five) years of age shall be exempted from passing the departmental tests prescribed in the Special Rules or the adhoc rules for the purpose of promotion to the next higher category i.e., promotion or appointment by transfer involving promotion to a post above the one held by him or her, if

they could not get even one promotion after their initial appointment.

2) The persons who already got a promotion once where no tests are prescribed for the higher post, the exemption is not applicable to him or her if he or she is to be considered for further promotion to next higher category where tests are prescribed.

3) The exemption is applicable in case of departmental tests or special tests only, where they are prescribed as prerequisite for promotion and this exemption shall not be applicable where like technical or academic qualifications are prescribed for promotion to the next higher category of posts.

4) The exemption shall not be applicable for declaration of probation, where passing of departmental tests or special tests is a pre-condition for declaration of probation.

4. As per the above orders, the employees/Teachers who have crossed 45 years of age shall be exempted from passing the Departmental Tests as prescribed in the service rules for appointment to the Special Promotion Post Scale. I (i.e. 1st level promotion Post Scale) subject to conditions laid down in Automatic Advancement Scheme rules. Rules are there fore very clear that the exemption shall be given only once in the entire service i.e. for the 1st level promotion post scale.

The Director of Treasuries and Accounts in his letter No. M1/3309/2008, dated 6-1-2009 brought to the notice of the Government that certain claims of Teachers preferred to The District Treasury, Vijayawada (West) on SPP-II to Scales were returned unpassed by the Treasury for the reason that they were not in accordance with the rules of the Automatic Advancement Scheme as the exemptions given to these Teachers were as per G.O.Ms.No. 95. Education Dept., dated 25-7-2005 which deals with the educational service rules only but not with the rules of Automatic Advancement Scheme. Para 10(IV) of the GO. lays down that any person appointed by promotion to any post after completion of 50 years of age shall be exempted from passing the Departmental test as referred to him Column 3 of the said G.O. This provision enables the Teachers to have second / Subsequent promotion, after the first exemption at 45 years. This rule is how ever applicable only to the service promotions but not to the appointment to the SPP-II post Scale. The Deputy Director, District Treasury, Krishna there fore issued instructions to the Treasury Officers in Krishna District, not to admit such claims, who were appointed to SPP-II Scale irregularly on attaining the age of 50 years.

 Aggrieved by these instructions, the Teachers concerned filed OA No. 7991/2008 and batch to set aside the afore mentioned instructions issued in Memo No. 02/1087/ 2008, dt. 19-2-2008 by the Dy. Director, District Treasury, Krishna District.

7. The APAT in their orders dated 18-12-2008 taken a view that the respondents did not follow the procedure prescribed by the Government in Finance Department in Circular Memo No. 22498-A/553/A1/PC.1/2005, dated 8-9-2005 in which a procedure was prescribed in respect of erroneous fixation of

pay and issued certain instructions to the Treasury Officers / PAO, Hyderabad and the PAO, Projects/Officers of State Audit. As per these instructions, the Audit Officers have to report the number of cases of erroneous fixations to the DTA/DSA/Finance (Projects) Department who will in turn consolidate and furnish the information to the Government in Finance (PC.I) Department. Any further clarification in this regard was to be sought from the Government Finance (PC.I) Department. The APAT taking the afore mentioned view arrived as follows:

"It is clear that the aforesaid procedu; as prescribed in Cir. Memo. Dt. 8-9-2005 has not been followed by the respondents while passing the impugned orders stopping the payment in accordance with the fixation of SPP-II scale and for recovery. There fore, the impugned orders in all these OAs are liable to be set aside. Accordingly, the OAs are allowed by setting aside the impugned order and the matter are remanded back to the concerned District Treasury Officers to follow the prescribed procedure as prescribed in circular Memo. Dt. 8-9-2005 and therefore, pass the bills of the applicants. As the impugned orders are set-aside the respondents are directed to pay salaries to the applicants SPP-II scale as fixed in view of completion of 24 years of service till orders are passed by the District treasury Officer in accordance with the procedure enunciated in the aforesaid Memo. after getting clarification from the Finance Department, VMAs dismissed."

 In view of the directions of the APAT as above, the District Treasury Officer, Vijayawada (West) vide his D.O. Lr.Rc.No. A2/102/2008, dt. 1-1-2009 and the DTA vide his Lr.No. M1/3309/2008 dt. 6-1-2009 requested the Government to issue necessary clarification in this regard.

 To avoid any further legal complications, and as per the directions of the APAT in the aforementioned OAs, the DTA, A.P. Hyderabad and the DTO, Vijayawada (West) are clarified as follows:

Orders were issued in GO.(P) No. 241 Finance (PC-II) Dept., dt. 28-9-2005, modifying certain aspects of Automatic Advancement Scheme with regard to fixation of pay of eligible employees under A.A. Scheme in the Revised Scales of Pay 2005, in the revised scales as indicated in Annexure-I, whereas as in the Govt. Cir. Memo. No. 22498-A/553/A1/PC.I/2005 Finance (PC.I) Dept., dt. 8-9-2005 certain procedural instructions were issued for fixation of pay of the employees were issued laying down procedure in implementation of Revised Scales 2005 as a sequel to the orders issued in GO.(P) No. 213 Finance (PC.I) Department dt. 27-8-2005 in which orders for implementation of Revised Scales 2005 were issued.

10. The orders issued on A.A. Scheme in G.O.(P)No. 241 Finance (PC.II) Department dt. 28-9-2005 are as per the recommendations of the PRC 2005 (8th PRC). At para 5 of the G.O.(P)No. 241 Finance (PC.II) Dept., dt. 28-9-2005, it is clearly mentioned that "all conditions laid down and orders instructions issued from time to time regarding the scheme, will

continue to apply in so far as they are in consonance with these orders." Accordingly, orders issued at para 3(C) of the GO.(P) No. 150 Finc. & Plg. (PC.II) Dept., dt. 1-9-1999 making the employees eligible for SPP Scales who were exempted from passing departmental tests as prescribed in the service rules, on attaining the age of 45 years as per the G.O.Ms.No. 225 GA (Ser.C) Dept., dt. 18-5-1999 are also covered by GO.(P) No. 241 Finance (PC.II) Dept., dt. 28-9-2005. But, no such orders were issued in respect of G.O.Ms.No. 95 Education (Ser.I) Department, dt. 25-7-2005 which envisages 2nd exemptio on completion of 50 years of age, in respect of Teachers. The Sub-rules (4) of Rule 10 of A.P. School Education Service Rules issued in GO.Ms.No. 95 Education dated 25-7-2005 States that the candidates who were appointed as teachers by direct recruitment on attaining the age of 50 years shall be exempted from passing the departmental test referred to in sub-rule (1) for the purpose of promotion and not for Automatic Advancement Scheme. Hence, the exemption of departmental tests is applicable to Secondary Grade Teachers, School Assistants etc., who are selected by direct recruitment and gets initial appointment is after 50 years of age. Therefore, the question of exempting the teachers who are recruited before attaining the age of 50 years, for the purpose of appointing them to the Special Promotion Post Scale-II under Automatic Advancement Scheme does not arise.

11. There fore, the claims preferred in SPP-II Scale without acquiring prescribed qualifications for the next promotion post to the 1st level promotion post to the original post in respect of the Teachers, on the ground that they got 2nd exemption on attaining the age of 50 years is not in accordance with the rules laid down for SPP-II scale under Automatic Advancement Scheme.

I invite your kind attention to the subject cited, It is submitted that the JACTO,AP..HYDERABAD has represented for admittance of SPP II scale(second level promotion) in RPS 2010 to the category III teachers under the exemption clause for subsequent promotion as-envisaged in the service rules on crossing 50 years of age. In support, of the JACTO has referred the amended service rules for the post of Head Masters Grade-II issued in the Government orders referred to at reference 3rd to 6th cited.

As per the said amended service Rules for the post of Head Master Grade-II at rule 7(iii)(a),all persons who have crossed 45 years of age shall be exempted from passing Departmental tests for promotion to the next higher category above the one held by him/her. and as per rule 7(iii)(b)all persons who have completed 50 years on the date of appointment to any post shall be exempted from passing the tests, it is submitted that the JACTO has referred the para 3(d)of the G.O.Ms.No:93 Fin(PC-II) Dept.dt;03-04-2010 which reads as "where the service Rules are relaxed to enable regular promotions, they should be automatically extended to get the benefit under Automatic Advanced Scheme".

In this regard I have to state that, as per provision 3(d) under the Automatic Advancement Scheme in RPS-2010 issued in G.O.M.s NO.93 Fin(P.C-II) Department ,dt:03-04-2010 was considered under G.O Ms.No:225 General Administration(Ser.c)Dept.dt:18-05-1999 as referred at reference 14th cited in the G.O.As per G.O Ms.No:225 GAD. dt:18-05-1999 the exemption for passing Departmental tests for next promotion was allowed to those who have crossed 45 years of age .And it was also specified in the G.O that the persons who already got a promotion once where is no tests are prescribed for the higher post, the exemption is not applicable. Further it is submitted that in the Education service rules referred to above for the exemption from passing the Departmental tests to all persons who have crossed 45 years of age is extended only to ensure that every employee gets atleast one promotion during his entire service and this exemption shall be given only once in the entire service. where as the exemption under Rule7(iii)(b) is allowed to all persons who have completed 50 years on the date of appointment to any post. Further it is submitted that in the Government Memo 7th cited for the settlement of claims under Automatic Advancement Scheme in RPS 2005 under the provisions of Education service rules issued in G.O.Ms.No;95 Education(ser.1)Dept,dt:25-07-2005, it was categorically clarified that. the exemption of Departmental test on crossing 50 years of age is applicable to the Secondary Grade Teachers, school Assistant etc, to the employees who are selected by direct recruitment and gets initial appointment after 50 years of age. Therefore the question of exempting the Teacher who are recruited before attaining the age of 50 years for the purpose of appointing them to the special promotion post scaleII does not arise.

In view of above it is presumed that allowing sppII scale under Automatic Advancement scheme under RPS 2010 to the Grade III teachers on crossing 50 years of age shall be second time exemption which is not admissible under the service rules on the same analogy adopted in the Govt memo 7th cited.

Therefore it is requested for confirmation of the presumption submitted above for settlement of Automatic Advancement scale claims of teachers under RPS2010.

The attention of the Director of Treasures and Accounts is invited to the references cited and he is informed that in response to his earlier Lr.No.M1/3309/2008.dt.06/01/2009,Govt in finance (PC-II)department has issued a clarification on the orders of G.O.Ms.No.95 Education (services –I) department dt.27.05/2005 with regard to second exemption on completion of 50 years of age to the teachers vide Memo.No.21073/193/PC-II/2009 Finance (PC-II) department dt.21/02/2009.The sub rule(4) of Rule10 of A.P.School Education service rules issued in G.O.Ms.No.95 Education dt.27/05/2005 states that the candidates who were appointed as teachers by direct recruitment on attaining the age of 50 years shall be exempted from passing the departmental test referred to in sub-rule(1)for the purpose of promotion and not for Automatic Advancement Scheme. Hence, the exemption of departmental tests is applicable to Secondary Grade Teachers, School Assistants etc... who are selected by direct recruitment and gets initial appointment after 50 years of age .This provision is applicable to the employees whose intial appointment is after 50 years of age .Therefore, the question of exempting the teachers who are recruited before attaining the age of 50 years for the purpose of appointing them to the Special Promotion Post Scale-II under Automatic Advancement Scheme does not arise.

- 2. There fore the claims preferred in SPP-II scale without acquiring prescribed qualification for the next promotion post to the 1st level promotion post to the original post in respect of the teachers on the ground that they have got 2nd exemption on attaining the age of 50 years is <u>not in accordance with</u> the rules laid down for SPP-II scale under Automatic Advancement Scheme.
- 3.
