**IMPORTANT NOTE:**

7. Fee for Regular candidates for all subjects is Rs.125/-
8. Fee for upto three and less than 3 subjects is Rs.110/-
9. Fee for more than 3 subjects is Rs.125/-
10. Fee for Vocational candidates is Rs.60/- in addition to Regular Examination fee of Rs.125/- prescribed for SSC academic courses.
11. Online Application link will be available in [www.bseap.org](http://www.bseap.org) website. The applications of all the candidates shall be uploaded online without fail.
12. The candidates belonging to Scheduled Castes / Scheduled Tribes and Backward Classes who are appearing for SSC **March 2019** for the first time as Regular candidates and whose parental income does not exceed **Rs.24, 000/- per annum in urban areas and Rs.20, 000/- or land holding not exceeding 2.5 Acres wet land / 5 acres dry land in Rural areas** are exempted from the payment of examination fee. As such, the Headmasters are requested to satisfy themselves about the Parental income by insisting upon a certificate issued by the Mandal Revenue Officer as per rules.
