Fee for underage candidates shall be remitted through **CFMS Challan** only.

- (14) Due dates of remittance of Examination fee will not be extended further under any Circumstances.
- (15) All the HMs are instructed to not to wait till the last date of remittance of Examination Fee.
- (16) Examination Fee shall be remitted through www.bse.ap.gov.in website well before the due dates to avoid any heavy traffic on the server.
- (17) The procedure for payment of Examination fee is clearly shown in the Instructions/User manual given to the HMs for online submission of Nominal Rolls.
- (18) Payment shall be done only through the **School Login** from **www.bse.ap.gov.in** website.

- 19. Fee for up to 3 subjects is Rs.110/-
- 20. Fee for vocational candidates is Rs 60/- in addition.
- 21. Fee for under aged candidates is Rs 300/-
- 22. Fee for Migration certificate, if required Rs. 80/-
- 23. Online Applications link will be available in www.bse.ap.gov.in website. The HM has to login with their User Id and Password which is already given to them.
- The candidates belonging to Scheduled Castes/ Scheduled Tribes 24. and Backward Classes who are appearing for SSC PE March/April -2024 for the first time as regular candidates and whose parental income does not exceed Rs.24,000/- per annum in urban areas and Rs 20,000/or land holding not exceeding 2.5 Acres wetland/5 acres dry land in rural areas are exempted from the payment of examinations fee. As such the Headmaster is requested to satisfy themselves about the Parental income by insisting upon a certificate issued by the Mandal Revenue Officer (M.R.O) as per rules.
