

- 6. Fee for Regular candidates for all Subjects is Rs. 125/-
- 7. Fee more than 3 Subjects is Rs. 125/-
- 8. Fee for upto 3 subjects is Rs.110/-
- 9. Fee for vocational candidates is Rs 60/- in addition.
- 10. Fee for under aged candidates is Rs 300/-
- 11. Online Applications link will be available in www.bseap.org website. The HM has to login with their User Id and Password which is already given to them.
- 12. The candidates belonging to Scheduled castes/ Scheduled tribes and Backward classes whom are appearing for SSC MARCH- 2020 for the first time as regular candidates and whose parental income does not exceed Rs.24,000/- per annum in urban areas and Rs 20,000/- or land holding not exceeding 2.5 Acres wetland/5 acres dry land in rural areas are exempted from the payment of examinations fee. As such the Headmaster is requested to satisfy themselves about the Parental income by insisting upon a certificate issued by the Mandal Revenue Officer (M.R.O) as per rules.
