# SSC/OSSC/VOCATIONAL PUBLIC EXAMINATIONS - MARCH/APRIL - 2024

The following are the revised due dates for remittance of Examination fee for Regular and Once failed candidates appearing for the SSC Public Examinations to be held in March/April - 2024. The Heads of institutions of all schools shall remit the Examination fee. Apart from Examination fee, Fee for Vocational candidates & for Migration certificates shall be remitted online along with NR submission in the website <a href="www.bse.ap.gov.in">www.bse.ap.gov.in</a> as per the schedule given below. Fee for underage candidates shall be remitted through **CFMS Challan** only.

- (7) If any of the above dates are declared as Public Holidays, the next immediate working day may be reckoned for the purpose.
- (8) Due dates of remittance of Examination fee will not be extended further under any Circumstances.
- (9) All the HMs are instructed to not to wait till the last date of remittance of Examination Fee.
- (10) Examination Fee shall be remitted through www.bse.ap.gov.in website well before the due dates to avoid any heavy traffic on the server.

- (11) The procedure for payment of Examination fee is clearly shown in the Instructions/User manual given to the HMs for online submission of Nominal Rolls.
- (12) Payment shall be done only through the **School Login** from **www.bse.ap.gov.in** website.

#### IMPORTANT NOTE:

- 9. Fee for Regular candidates for all Subjects is Rs. 125/-
- 10. Fee more than 3 Subjects is Rs. 125/-
- 11. Fee for up to 3 subjects is Rs.110/-
- 12. Fee for vocational candidates is Rs 60/- in addition.
- 13. Fee for under aged candidates is Rs 300/-
- 14. Fee for Migration certificate, if required Rs. 80/-
- 15. Online Applications link will be available in <a href="www.bse.ap.gov.in">www.bse.ap.gov.in</a> website. The HM has to login with their User Id and Password which is already given to them.
- 16. The candidates belonging to Scheduled Castes/ Scheduled Tribes and Backward Classes who are appearing for SSC PE March/April 2024 for the first time as regular candidates and whose parental income does not exceed Rs.24,000/- per annum in urban areas and Rs 20,000/- or land holding not exceeding 2.5 Acres wetland/5 acres dry land in rural areas are exempted from the payment of examinations fee. As such the Headmaster is requested to satisfy themselves about the Parental income by insisting upon a certificate issued by the Mandal Revenue Officer (M.R.O) as per rules.
