



- That the appointment is purely temporary subject to the directions/judgements issued by Hon'ble Courts from time to time and this appointment is purely on adhoc basis.

- That the Headmaster/Mandal Educational Officer shall make an entry in the Service Register of the applicant incorporating all the conditions and undertaking obtained from him.
