In the Government Memo cited certain clarifica. tions were issued in regard to AutomaticAdvauceme. nt Scheme in the Revised Scales of 1978. At item No. 5 of the Memo. cited, It was clarified that in cases of reversion at request to a lower post, it is not correct to deprive the employee of his claim to be appointed to the special Temporary promotion post or Special Adhoc promotion post if he is qualified for those posts. Therefore not with standing the request for his reversion to a lower post, he should be appointed to the special temporary promotion post or Special Adhoc promotion post, as the case may be if he is otherwise qualified for holding these post under the rules applicable to such posts.

2 In the reference 2nd cited. the joint Dire. ctor of Agriculture, Warangal has sought a elari. fication, whether the benefits Automatic Advance-ment Scheme can also be extended to the Individuals who have relinguished their right of promotion permanentely and their option has been accpted by the authority, as stipulated in rule 45 of A.P. State and Subordinate service Rules.

3. In this connection, it is hereby clarified that the concept of Automatic Advancement Scheme for 15/22 years is that a persons should be fully eligible for promotion and that he is not able to secure promotion on account of non-availability of vacancy. In cases where a persons relinquishes his right permanently to promotion under General Rule 45 of A. P. State and subordinate Service Rules he should not be made eligible for the bene. fit of the Automatic Advancement Scheme. Similarly where a person, is reverted to a lower post his request, he should not be eligible for the Automatic Advancement Scheme. Both these situa. tion are synonymous.

keeping this as well as the basic concept of Automatic Advancement Scheme the clarification to Item. (5) of Government memo. No. 41086 B 202/PRC.I/81.I, dt. 31_12-81 is hereby cancelled

5. All the Departments of Secretariat and the Heads of Departments are requested to bring the clarificatory instructions to the notice of the appointing authorities concerned.

In Andhra Pradesh State and Subordinate Service Rules, 1996 joining time is prescribed both for appointment by direct recruitment and for appointment by promotion/transfer. In case of appointment by promotion / transfer the existing time limit is 15 days from the date of receipt of the appointment order. Failure to join duty in the post for which the employee is appointed by promotion / transfer results in forfeiture of the presentof and future rights of promotion / appointment by transfer. As a result of the above condition, a government employee who does not join in the promotion post within the stipulated time loses his promotion rights to the next higher category permanently. It is noticed that for several reasons employees could not join in the promotion posts in the allowed time. To mitigate the hardship to the Government employees, the Government decided to consider, such of those Government empoyees who could not join duty in the promotion posts, in the next panel year. Accordingly Government have decided to issue the following amendment to rule 11(b) of Andhra Pradesh State and Subordinate Service Rules, 1996.

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India the Governor of Andhra Pradesh hereby makes the following amendment to the Andhra Pradesh State and Subordinate Service Rules, 1996 issued in G.O.Ms.No.436 G.A. (Ser.D) Dept., dated 15th October, 1996 published in part-I Extraordinary issue of the Andhra Pradesh Gazette dated the 27th January, 1997 as subsequently amended from time to time.

AMENDMENT

In the said rules, in rule 11 for sub-rule (b), the following shall be substituted namely :-

"(b) Time to join a post on appointment / temporary appointment under rule 10 inclusing appointments by transfer or by promotion otherwise than by direct recruitment: A person on appoitment / temparary appointment on adhoc basis under rule 10 including appointment by transfer or by promotion otherwise than by direct recruitment, shall be allowed a joining time of fifteen (15) days to join the post from the date of receipt of the order of appointment sent to the candidates by Registered Post with Acknowledgment due or by any other means. An employee who does not join the post within the stipulated time or evades to join the post by proceeding on leave, shall lose his promotion right/offer for the current panel year and the name of the candidate shall be places before the next Departmental Promotion Committee for consideration in the next year panel subject to avialability of vacancy. In case of non-selection posts, the name of the candidate who does not join within the stipulated time in the promotion posts shall be cansidered for promotion again after a period of one year from the date of offer of appointment subject to availability of vacancy".
