"The concept of AAS is to relieve stagnation in service that an employee should be fully eligible for promotion and he is not able to secure promotion on account of non-availability of vacancy. There is no provision in that scheme that an employee shall be appointed to SPP Scale-I and SPP Scale-II with retrospective date of completion of 16/24 years of incremental service and giving monetary benefit w.e.f., the date of possessing the academic qualifications/passing of prescribed Departmental Tests etc., even after completion of 16/24 years of service".

Attention of the DD, DT Visakhapatnam is invited to the ref 2<sup>nd</sup> cited. The Government have issued several clarifications on the Eligibility and modalities of Automatic Advancement Scheme applicable to the Government employees from time to time. In spite of that requests are received often seeking further clarification or directions to the Treasury officers to admit some individual claims. One among such clarifications sought for is that whether a Government servant who is not qualified to get promotion at the time of his completing 12 years of service and who has qualified thereafter is entitled to be appointed to SPP-IA as on the date of his completion of 12 years with monetary benefit from the date of his acquiring the required qualification/Eligibility to get promotion.

This question has already been clarified by the Government vide Memo No.17509/146/PC2/A1/2012,Dt:09.08.2012 of Finance (PC-I) Department wherein the Government have confirmed the following presumptions of this office.

"The appointment of the individual to SPP Scale-I and SPP Scale-II on completion of 24 years of service is not in order because of the concept of Automatic Advancement Scheme is to relieve stagnation in service that an employee should be fully eligible for promotion and he is not able to secure promotion on account of non-availability of vacancy. His junior has already been promoted earlier that him. There is no provision in that scheme that an employee shall be appointed to SPP Scale-I and SPP Scale-II with retrospective date of completion of 16/24 years of incremental service and giving monetary benefit w.e.f. the date of possessing the academic qualifications/passing of prescribed Departmental Tests etc. even after completion of

16/24 years of service and also the juniors promoted in regular line earlier than the senior. Therefore the appointment of the individual to SPP Scale – I w.e.f. 24.01.1991 with monetary benefit w.e.f.30.11.2003 i.e. from the passing of Accounts Test is not in order".

So the above presumption was referred to the Government through this office Letter No M1/14078/2010,Dt:24.08.2010. The same is applicable in respect of Automatic Advancement Scheme existing today. All the Treasury Officers should take necessary action in this matter.

I submit that the Deputy Director, Visakhpatnam has sought for clarification on eligibility of SPP – I scale to those who have acquire requisite qualification after completion of 24 years of service.

Further, I submit that Government have issued clarification vide Memo 2<sup>nd</sup> cited that the concept of Automatic Advancement Scheme for 15/22 years (now 16/24 years) is that a person should be fully eligible for promotion and that he is not able to secure promotion on account of non-availability of vacancy. In cases where a person relinquishes his right permanently to promotion under General Rule 45 of A.P. State & Subordinate Service Rules should not be made eligible for the benefit of Automatic Advancement Scheme.

Further I submit that Government have issued another clarification vide memo 3rd cired that if an individual eligible for promotion to the higher post on regular line from the ordinary Grade Scale Post but his name is not approved in DPC, due to disciplinary case pending against him and his juniors are promoted in the same DPC therefore the individual is not eligible for Special Grade Post Scale as he has not stagmated in service but could not be considered for promotion.

The Deputy Director Visakhpatnam has informed that in the Judicial Department of Visakhpatnam District it is noticed during the course of pre – audit of bill, the District Judge, Visakhapatnam has appointed certain Typicts/Junior Assistants to SPP – I Scale in a particular category of post even after completion of 16 years of service and even their juniors promoted earlier than them.

Case Example :-

Sri.R.Kesavarao, who was initially appointed as copyist on 13-11-1972. He was promoted as Typist w.e.f. 22-01-1975. He has completed 16 years of incremental service as on 24-01-1991. Due to his not acquiring requisite Departmental Tests i.e. passing of Accounts Test for Subordinate Officers and other Tests he has not appointed to SPP Scale— I and he could not be promoted to the next promotion post of Senior Assistant along with his juniors till he possessed Departmental Tests i.e. up to 30-11-2008.

In the above aspect it is my opinion that the appointment of the individual to SPP Scale – I and SPP Scale –II on completion of 24 years of service is not in order because of the concept of Automatic Advancement Scheme is to relieve stagnation in service that an employee should be fully eligible for promotion and he is not able to secure promotion on account of non-availability of vacancy. His junior has already been promoted earlier that him. There is no provision in that scheme that an employee shall be appointed to SPP Scale – I and SPP Scale –II with retrospective date of completion of 16/24 years of incremental service and giving monitory benefit w.e.f the date of possessing the academic qualifications/passing of prescribed Departmental Tests etc., even after completion of 16/24 years of service and also the juniors promoted in regular line earlier than the senior. Therefore the appointment of the individual to SPP Scale – I w.e.f. 24-01-1991 with monitory benefit w.e.f. 30-11-2003 i.e from the passing of Accounts Test is not in order.

In view of the above, I request the Government kindly confirm my presumption mentioned above.

# GOVERNMENT OF ANDHRA PRADESH ABSTRACT

PUBLIC SERVICE - Applicability of ruling under F.R. 26(a) conferring of right to draw increment or any benefit or concession on the Government servants on the day following the last day of the examination of test which an individual passes - Clarification - Issued.

### GENERAL ADMINISTRATION (SER.A) DEPARTMENT

G.O.Ms.No.270

Dated the 30th April, 1984.

#### ORDER:

The issue relating to the correct view that has to be taken on the applicability of ruling under Fundamental Rule 26(a) i.e., conferring of right to draw increment or any benefit or concession on the Government Servants on the day following the last day of the examination or test which an individual passes to matters relating seniority, promotion etc., has been under the consideration of Government for some time past. To keep the matters free from doubt and to avoid the scope of mis-interpretation to the above ruling, the following clarification is issued with a view to have an uniform pattern while deciding such cases in public Services.

2. The ruling under fundamental Rule 26(a) reads as follows:

- "(1) If a probationer is confirmed at the end of a period of probation exceeding twelve months, he is entitled to claim retrospectively the increments which, but for his probation, he would have received in the ordinary course.
- (2) In cases where the passing of an examination or test confers on a Government Servant the title to any right, benefit or concession, such titles should be deemed to have accrued on the day following the last day of the examination or test which he passed. In cases where the examination or test can be passed in instalments, the title to the right, benefit or concession will be deemed to have accrued on the day following the last day of the examination in the subject or subjects in which he has passed etc.
- NOTE: The right conferred by passing the examination is the right to draw an increment from the day following the last day of the examination, provided that the person concerend is otherwise eligible for the increment".
- (3) The Andhra Pradesh Administrative Tribunal, in a case, has observed that the ruling under Fundamentl Rule 26(a) cannot be interpreted to affect adversely the rights which accrued to another person in service who had been validly promoted under rules. In fact, it cannot be stretched to reverse the seniority of or the right accrued to any particular individual. The ruling under Fundamental Rule26(a) has been in consonance with the principles of natural justice and cannot have the result of reversing the seniority of a person validly promoted under the rules.
- (4) The aforesaid ruling (2) under Fundamental Rule 26(a) prescribed the conditions for the grant of increments. It is now a settled principle of interpretation that the context in which a provision is made should not be lost sight of. In view of this, ruling (2) under to be confined only to the sanction of increments and its scope promotions etc.
- (5) All the Departments of Secretariat, Heads of Departments are, therefore, requested to keep the above position in view while examining cases under the provisions of Fundamental Rule 26(a).

Memo No M1/14078/2010 dt 24/08/2010 & 20/06/2012 of the DTA and Memo No H1/6697/2014 dt 05/08/2015 of the DTA has been clarified that the concept of AAS is relieve stagnation in service that an employee should be fully eligible for promotion and he/she is not able to secure promotion on account of non availability of vacancy and rejected appointment of an individual who passed the departmental test after completion of 12 years of service but in the instant case the individual has been passed the required test after expiry of 12 years hence AAS is not admissible in this case

Hence the bill is re transmitted to STO ,Sattenapalli for rectification of the aforesaid omissions/defects

Asper Govt Memo. No.17509/146/PC.II/A1/2012 dt: 09-08-2012 has confirmed that there is no provision in AAS scheme that an employee shall be appointed to SPP Scale-I and SPP Scale-II with retrospective date of completion of 16/24 years of incremental service and giving monitory benefit wef the date of possessing the academic qualifications/passing of prescribed departmental tests etc., even after completion of 16/24 years of service. Therefore the appointment of the individual to SPP-II wef 03-12-2020 with MB wef 09-03-2021 ie., from the passing of accounts test is not in order.

Hence the bill is returend.
