#### ORDER:

In the references 1st, 3rd and 4th read above, it has been reported that the Government in G.O.Ms.No.429, Education, dated:13.10.1983, issued orders for creation of Special Teachers and Special Language Pandits on payment of consolidated pay of Rs.398/- p.m. without any allowances and that they are not eligible for any kind of leave except casual leave and maternity leave in case of Women teachers. It has also been reperted that in the meetings held on 30.8.1994 and 31.8.1994, the members of FAPTO and JACTA represented that the period of consolidated payment rendored by the special teachers, special language pandits and special P.E.Ts. appointed during 1983-84 to 1985-86, may be regularised so as to count the same for the purpose of sanction of 10/15/22 years scale and other retirement benefits.

2. In the reference 2nd read above, the President of the Panchayat Raj Union, Andhra Pradesh has represented that the Hon'ble Chief Minister has announced during the 21st State Council Meeting of Panchayat Raj Teachers Union that the service rendered by the Special teachers, Special Language Pandits and Special P.E.Ts. will be counted for 8/16 years increments and for pension purposes also.

3. The Government have examined the issue and it was decided to count the temporary service of the Special teachers, Special Language Pandits and Special P.E.Ts., who were appointed between the years 1983-86 with a consolidated pay of Rs.398/- p.m. and absorbed in regular post, on notional basis for sanctioning 8/16 years promotion scale under Automatic Advancement Scheme and for pensionary benefits.


4. Accordingly, Government hereby order, that the temporary service of the Special Teachers, Special Language Pandits and Special P.E.Ts. who were appointed between the years 1983-1986 with a consolidated pay of Rs.398/- p.m. and absorbed in regular posts, should be taken into account on notional basis for sanctioning 8/16 years promotion scale under automatic advancement scheme and also for pensionary benefits.

In G.O.Ms.No.119, Education, dt.21- 4- 98, orders have been Issued that the temporary service of Spincial Teachers, Special Language Pandits and Special P.E.Ts, who were appointed between the year 1983 - 86, with a consolidated pay of Rs. 398/- P.M., and absorbed in regular posts should be taken into account on notional basis for sanctioning 8/16 years promotion scale under Automatic Advancement Scheme and also for pensionary

- Certain Teacher Unions have represented that the services of Special Teachers, Special Language Pandits and Special P.E.Ts appointed during the year 1986 - 90 on a consolidated pay of Rs.398/-P.M. should be regularised and the benefit of promotion scale under Automatic Advancement Scheme, as given in G.O.Ms.No.119, Education, dt 21-4-98, for the teachers appointed prior to 1986, shall be extended to them. 3.
- The Cabinet Sub- Committee has discussed this at length and agreed with the request made by the Teachers
- Accordingly, Government after careful consideration hereby direct that on par with the teachers appointed prior to 1986, the orders issued in G.O.Ms. No. 119, Education, dt. 21-4-98, shall be extended to them and the temporary service of Special Teachers Special Language Pandits, and Special P.E.Ts who were appointed between the years 1986 to 1990 with a consolidated pay of Rs. 398/- P.M. and absorbed into regular posts, should be taken into account on notional basis for sanctioning 8/16 years promotion Scale under Automatic Advancement Scheme
- The Commissioner and Director of School Education, Is directed count the services of teachers on notional basis only and the monetary benefit, if any, may be given from the date of issue of Government orders, after vertication · of qualification, age, service particulars, etc. 6.
- Government further direct that the Chief Executive Officers/District Educational Officers shall verify the above aspects in each individual case and take further action. Any Improper counting of service shall be viewed apriously and the financial implication loss sustained to the Government on account of such irregular action is liable to be recovered from the staff concerned apart from taking other action as per rules.

The attention of the under mentioned District Education tional Officers in the State is invited to the references 1st 5th read above, and they are informed that certain teach ers were appointed as Special Teachers under Rs.398/- p month basesd on Hon'ble High Court of Andhra Pradesh Judgement dt.28-8-2000 in W.P.No.1058 10683,109684,10685,10686,10687, of 1999.

The Special Teachers are constantly representing to their abserption. The Hon'ble High Court directed to a point the Petitioners strictly in order of merit. According

the directions of Hon'ble High Court, the Government in their Memo.No.18788/Ser.VI/99, (Education Ser.VI Department) dated: 23-5-2001 had orderd for implementation of High Court orders dt.28-8-2000 in W.P.No.10586/99 and batch. According to the directions of the Hob'ble High Court the District Educational Officers' in the State has completed the process of recruitment as per the schedule given by this office. These Special Teachers working on Rs.398/- consolidated pay have to be absorbed against regular vacancles, as and when the vacancies arise as per the original scheme, simultaneously winding up the posts of Special Teachers. According to the various Government Orders on the Special Teachers so appointed at Rs.398/- consolidated scheme as per the directions of Hon'ble High Court be aborbed, against the regular S.G.T. posts in the available acancies in the district other than these notified during S.C.2001. The absorption should be made only in respect If these, who have been appointed strictly as per guidenes issued in reference 5th read above, and working as on he date of isue of these orders.

Since any new appointments to the post of S.G.T. urles stipend during the first year, at the rate of Rs. 1,200/ per month and Rs. 1,500/- P.M. in second year, these Speal leachers, on absorption, shall be paid the stipend, as ppllacable to the newly recruited S.G.T Teachers and they hould be put on apprenticeship for two years.

The Seniority of the special Teachers now abosrbed all be reckened from the date of their absorption into the gular vacancies of S.G.T.

The Hon'ble High Court of A.P. Hyderabad in its order, dated 28.8.2000 in WP.No. 10586/99 and batch relating to DSC-89, Special Teachers has directed as follows:

"There are 912 vacancies, which left unfilled because of the erroneous interpretation and importing the panel-theory and as there are more number of qualified candidates among the petitioners, the petitioners have to be arranged in terms of their merit among them and in order of that merit, the appointments are to be made. We make it clear that such of 911 petitioners, who stand qualified to be appointed in order of the above merit, shall continue and others have to pave the way for more meritorious candidates basing upon the merit list. W reiterate that merit list shall be drawn for 912 posts only among the writ pet tioners herein and shall not percolate beyond them for the reason of their initial tion of legal proceedings right on time and pursuing the same before sever forums right from A.P. Administrative Tribunal to that of Supreme Court an others even if they were qualified, had not initiated any legal proceedings at remained contented. This exericse shall be made by the appointing authorities within a period of one month the date of receipt of a copy of this order. It is pertinent to mention that the above 912 vacancies shall not from part of the selection process for recruitment of Teachers pursuant to DSC - 2000."

Accordingly, all the five writ petitions are disposed of No Costs.

The Government have issued the orders in the reference 2nd read above directing the Commissioner & Director of School Education. Hyderabad to implement the said order of the High Court

The Commissioner & Director of School Education. Hyderabad in his letter 3rd read above has stated that the A.P. Special Teachers Association, Hyderabad, in their representation, dated 6.2.2002 have submitted that they are working as Special Teachers since six years with consolidated pay of Rs.398/- and the Hon'ble High Court in its judgement dated 26.8.2000 in W.P.No. 10586/99 and batch has issued direction in favour of petitioners. The Government and the Commissioner and Director of School Education, Hyderabad have implemented the order of Hon'ble High Court, A.P., Hyderabad and they have been shown as apprenticeship teachers for which they are facing financial problems. They have requested to absorb them into regular scale. Further stated that, the President, S.T.U., A.P., Hyderabad, in their representation, dated Nil have represented to absorb the teachers into regular SGBT posts with full scale of pay but not to apprenticeship post. It was also mentioned that in the meeting held with the Teachers Unions the Government have accepted to absorb these teachers into regular posts and allotted Rs. 5.15 corers. In his Subsequent letter 5th read above the Commissioner and Director of School Education, Hyderabad submitted that the Special teachers have been selected through the District Selection Committees and also instructions were issued in his office Proc.Rc.No. 4196/G4/2001. dt.11.1.2002 for absorption of special teachers who are working as on 11.1.2002 and the seniority of special teachers now absorbed shall be reckoned from the date of their absorption into regular vacancies only. In his further letter 7th read above the Commissioner and Director of School Education, Hyderabad reported that out of 912 Special Teachers posts, 231 Special Teachers posts are kept vacant due to termination of unqualified candidates and 681 (Six hundred and eighty one only) teachers are working at present.

4. The Commissioner & Director of School Education, Hyderabad has requested the Government to issue suitable orders in the matter.

5. The Government have examined the matter and after careful consideration here by order that the meritorious petitioners who were appointed in pursuance of the order of the Honble A.P. High Court, dated 28.8.2000 in W.P.No. 10586/99 and batch be allowed regular time scale of pay of S.G.T. of Rs. 3750-7650 to 681 (Six hundred and eighty one only) Special teachers with effect from 11.1.2002 instead of apprenticeship in relaxation of orders issued in G.O.Ms.No. 72 Edn. (Ser.VI-A1) Dept dt.9.7.2000 read with G.O.Ms.No. 75 Edn. (Ser. VI-A1) Dept dated 19.6.2001.

The seniority of the 681 (Six hundred and eighty one only) Special Teachers be reckoned from the date of their absorption into regular vacancies of S.G.B.T. only.

# ORDER:

In the G.O.1<sup>st</sup> read above, orders were issued creating 912 Special Teacher Posts in the Districts for appointment of the petitioners in W.P.M.No.21607, 21608, 21609/93 in W.P.No.17104, 17105 and 17106/93 as per the High Court Orders, dated 03.04.1996 in Review W.A.M.P.No.2379, 2381, 2338 and 2385/95. Accordingly, Government directed the District Collectors to appoint the 912 petitioners on a monthly fixed remuneration of Rs. 398/- as Special Teachers, subject to review of the Hon'ble High Court.

- 2. In the G.O. 2<sup>nd</sup> read above orders were issued to the effect that the temporary service of Special Teachers, Special Language Pandits and Special P.E.Ts who were appointed between the year 1983-86 with a consolidated pay of Rs.398/- per month and absorbed in regular posts should be taken into account on notional basis for sanctioning 8/16 years promotion scale under Automatic Advancement Scheme and also for pensionary benefits.
- 3. Subsequently, based on the recommendations of the Cabinet Sub-Committee, orders have been issued in G.O.Ms.No.92, Education, dated 08.08.2000 extending the said benefit to the Special Teachers, special language Pandits and Special PETs who were appointed between the years 1986 to 1990 with a consolidated pay of Rs.398/- per month and absorbed into regular posts to the effect that their temporary service should be taken into account on notional basis for sanctioning 8/16 years promotion scale under Automatic Advancement Scheme and also for pensionery benefits.
- 4. In the G.O. 3<sup>rd</sup> read above, Government issued orders that the meritorious petitioners who were appointed in pursuance of the order of the Hon'ble High Court, dt.28.8.2000 in W.P. No.10686/99 and batch be allowed regular time scale of pay of S.G.T. of Rs.3750 7650 to 681 (six hundred and eighty one only) Special Teachers w.e.f. 11.1.2002 instead of apprenticeship in relaxation of orders issued in G.O.Ms.No.72, Edn.(Ser. VI) Dept., dt.5.7.2000 read with G.O.Ms.No.75, Edn.(Ser. VI) Dept., dt.19.6.2001, as they completed more than 5 years of adhoc service and to reckon the seniority of these 681 Special Teachers from the date of their absorption into regular vacancies of S.G.B.T. only.

- The Director of School Education, Hyderabad in his letter 4th read above has submitted that the President, 912 Special Teachers Association has represented that the benefit of Automatic Advancement Scheme duly counting the period from the date of their appointment as special teachers may be extended to these 681 special teachers.
- The Director of School Education, Hyderabad in his letter 6<sup>th</sup> read above has further stated that as per calculation of the 8 year scale, the additional financial expenditure comes to Rs.209/- per teacher. Accordingly for 12 months @ 209/- per teacher for 681 teachers there would be an additional commitment of Rs.17,07,948/- approximately per annum. He has therefore requested the Government, to issue necessary orders in the matter.
- Based on the minutes of the meeting convened by the then Hon'ble 7. C.M. with Teacher MLCs and JACTO leaders on 03.11.2008, Government have examined the matter and decided to extend the orders issued in G.O.Ms.No.119, Education (SE-Ser.III) Department, dated 21.04.1998 to the 681 Special Teachers who were appointed from 1996 onwards and absorbed as regular SGTs.
- Accordingly, Government hereby order that the temporary service of 8. the 681 Special Teachers, Special Language Pandits and Special P.E.Ts who were appointed from 1996 onwards with a consolidated pay of Rs.398/p.m. and absorbed in regular posts of SGTs, should be taken into account on notional basis for sanctioning 8/16 years promotion scale under Automatic Advancement Scheme and also for pensionary benefits. The monetary benefit shall be given from the date of issue of this order.
