O R D E R:

In the Government Order 1<sup>st</sup> read above, orders were issued constituting Ninth Pay Revision Commission and government appointed Sri C.S. Rao, IAS, (Retd.), as Pay Revision Commissioner.

2. The Ninth Pay Revision Commission submitted its report to the Government on 5-12-2009 and recommended, inter alia that, “as in the case of regulation of D.A. while on leave, the payment of H.R.A. & C.C.A. may also be allowed to State Govt. employees as applicable to the employees of Govt. of India. The Commission therefore recommends the payment of H.R.A./C.C.A. upto 180 days during leave of all kinds in the normal course.

3. In the Government order 2<sup>nd</sup> read above, it was ordered that the maximum earned leave that may be granted at a time to a government servant in superior service is enhanced from 120 days to 180 days on par with the employees of the Govt. of India.

4. After careful examination of the report, Government decided to accept the recommendations of the Pay revision Commissioner and hereby order that, the payment of HRA and CCA shall be allowed to State Govt. employees upto 180 days during leave of all kinds.

5. These orders will come into force with immediate effect.

**ORDER:**

In the Government Order 1<sup>st</sup> read above, orders were issued constituting Ninth Pay Revision Commission and government appointed Sri C.S. Rao, IAS, (Retd.), as Pay Revision Commissioner.

2. The Ninth Pay Revision Commission submitted its report to the Government on 5-12-2009 and recommended, inter alia that, “as in the case of regulation of D.A. while on leave, the payment of H.R.A. & C.C.A. may also be allowed to State Govt. employees as applicable to the employees of Govt. of India. The Commission therefore recommends the payment of H.R.A./C.C.A. upto 180 days during leave of all kinds in the normal course. However, in case the leave is granted to the employees who are suffering from Cancer and other ailments such as Mental illness, Heart diseases, Leprosy, renal failure and HIV Aids they may be paid HRA/CCA upto a period of 8 months. The Commission further recommends that if the employees are suffering from the above ailments, and who remain on leave for a period exceeding 8 months, the grant of HRA/CCA for the period of leave beyond 8 months may be decided by the Head of the Department concerned so long as the period of leave is supported by the Medical Certificate in the prescribed form. The commission feels that since TB is easily curable with advances in medicine there is no need to extend the facility to patients suffering from T.B.

3. In the Government order 4<sup>th</sup> read above, it was ordered that the maximum earned leave that may be granted at a time to a government servant in superior service is enhanced from 120 days to 180 days on par with the employees of the Govt. of India.

4. In the G.O. 2<sup>nd</sup> and 3<sup>rd</sup> read above orders were issued for the drawal of full pay to the extent of six months, in lieu of six months half pay leave, if at credit, by all regular Government servants, who are suffering from Leprosy/Tuberculosis/Cancer/Heart diseases and Mental Illness and Renal (Kidney) failure.

4. After careful examination of the report, Government decided to accept the recommendations of the Pay revision Commissioner and hereby order that, the payment of HRA and CCA be allowed to State Govt. employees upto 8 months during the leave availed on the ground of suffering from Cancer, Mental Illness, Heart diseases, Leprosy, Renal failure and HIV aids. Further, if the employees suffering from the above ailments, remain on leave for a period exceeding 8 months, the grant of HRA/CCA for the period of leave beyond 8 months shall be decided by the Head of the Department concerned so long as the period of leave is supported by the Medical Certificate in the prescribed form. This facility is not available to the Govt. employees suffering with T.B. since TB is easily curable with advances in medicine.

The Ninth Pay Revision Commission recommended, among others as follows on the admissibility of Dearness Allowance during the period of Leave on Half Pay:

**“The Employees of the State Government may be allowed Dearness Allowance based on the amount of leave salary admissible while on leave on Half Pay on par with the Employees of Government of India”.**

2. After careful examination of the recommendations of Ninth Pay Revision Commission, Government hereby order to adopt the orders as existing in Government of India on the admissibility of Dearness Allowance during Half Pay Leave for the employees of the State Government. The extract of the Rule 40 of the Central Civil Services (Leave) Rules, 1972 (FRSR-Part-2) is appended to this memo.

3. The Finance (FR.I) Department are requested to make necessary amendment to the A.P.Leave Rules / A.P.Fundamental Rules.

**ORDER:**

According to the orders issued in the G.O. 1st as amended in G.O 2nd read above, a Government employee proceeding on Half Pay Leave is entitled to leave salary to half of the pay drawn immediately before proceeding on such half pay leave and Dearness allowance correspondings to such half pay. Government have reached an agreement with the Employees' Association on 17.12.1993 and among other things it was agreed to allow full Dearness Allowance, House Rent Allowance and other allowances on half pay leave for those drawing upto the scale of Rs.3110-6380 and this will be effective from the date of issue of orders.

2. According to the orders in existence, the employees will get House Rent allowance and other allowances in full during the period of half pay leave except Dearness allowance which will paid proportionate to the pay. So, only the payment of Dearness allowance in full has to be restored in the light of the agreement referred to above.
3. Accordingly, Government hereby order that Dearness Allowance shall be paid in full during the period of half pay leave to the employees drawing pay in the scale of pay upto and inclusive of Rs.3110-6380. These orders will come into force with immediate effect.

Order:

According to the orders issued in Government Orders 2nd and 3rd read above, a Government employees proceeding on half pay leave is entitled to leave salary to half of pay drawn immediately before proceeding on such half pay leave and Dearness Allowance corresponding to such half pay. In the Government Order 4th read above, orders have been issued revising the rates of House Rent Allowance as recommended by the pay Revision Commissioner, 1993 by suitably amending the Andhra Pradesh Public Employment (House Rent Allowance) Rules, 1988.

2. While amending rule 3 of the said rule, the orders issued in the Government Orders second and third read above were not taken into account and the said amendment is contrary to the orders issued in the said Government orders. Therefore, it has been decided to amend the said rule suitably.
3. The following Notification shall be published in the Andhra Pradesh Gazette:

**NOTIFICATION**

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Andhra Pradesh hereby makes the following amendment to the Andhra Pradesh Public Employment (House Rent Allowance) Rules, 1988.

The amendment hereby made shall be deemed to have come into force with effect from the 1st January, 1993 with monetary benefit from the 1st April, 1993.

**AMENDMENT**

For sub rule (2) of rule (3) of the said rules, the following shall be substituted namely:

"(2) In respect to those who are on leave on full average pay or half average pay the allowance shall be calculated on the basis of pay drawn immediately before proceeding on such leave subject to F.R.44"
