In the reference 1st cited, orders have been issued to
release the salaries of non-local employees who have been
repatriated to their local cadre treating them as on OD initially,
pending creation of supernumerary posts.

In the reference 2nd cited, the Home Department has
stated that the concerned Unit Officers have reported that
the respective District Treasury Officers are not admitting the
pay bills of the individuals for want of supernumerary posts.
It was also reported that the District Treasury Officers are
not accepting the Government instructions by stating that they
were issued to the Education Department and also that no
instructions have been issued from Finance Department so
far. All the individuals who were transferred belong to Class-
IV employees, clerical and equivalent categories and they
are facing much hardship for want of salaries for the past 4
months. Hence, the Home Department has requested to issue
instructions to the Treasuries Department to release the
salaries of all the individuals pending creation of
supernumerary posts.

In view of the above, the Director of Treasuries and
Accounts, A.P. Hyderabad, the Pay and Accounts Officer,
Hyderabad and the Director of Works Accounts, A.P.
Hyderabad are instructed to issue instructions to their
subordinate officers to accept the salary bills of all the non-
local employees who have been repatriated to their local
cadre treating them as on OD initially, pending creation of
supernumerary posts.

ORDER:

In the G.O.2nd read above orders were issued revising
the rates of **House Rent Allowance (HRA)** to the State
Government employees as recommended by the Pay
Revision Commission, 2005. In the G.O.4th read above, the
ceiling on HRA was revised from Rs.3,000/- P.M., to Rs.4,000/
-P.M. basing on the recommendations of One Man
Committee.

2. In the G.O.6th read above, orders were issued
establishing Greater Hyderabad Municipal Corporation with
effect from 16-4-2007 by merging the following Municipalities
(1) L.B.Nagar, (2) Gaddiannaram, (3) Uppal Kalan, (4)
Malkajgiri, (5) Kapra, (6) Alwal, (7) Qutubullahpur, (8)
Kukatpally, (9) Serilingampally, (10) Rajendranagar,
(11) Ramachandrapuram and (12) Patancheru.

3. Government of India have classified Greater
Hyderabad Municipal Corporation as A-1 Class City for the
purpose of grant of HRA to the Central Government
Employees posted at Greater Hyderabad Municipal
Corporation vide reference 7th read above.

4. The Chairman, Joint Action Committee of Employees,
Teachers and Workers, A.P. Hyderabad and the President,
A.P. Secretariat Association have represented in the
references 8th and 9th read above, for revision of **HRA to 30%**
to the State Government employees working in the Offices
situated in the Greater Hyderabad Municipal Corporation.

5. Government, having examined the request and after
careful consideration, hereby order revising the rates of HRA
to 30% of basic pay to the State Government employees
drawing pay in the Revised Pay Scales, 2005 working within
the limits of the Greater Hyderabad Municipal Corporation,
subject to a maximum ceiling of Rs.6,000/- per month.

6. These orders are also applicable to the employees of
the Local Bodies and Aided Institutions including Aided
Polytechnics, the non-teaching staff of Universities of
Jawaharlar Nehru Technological University, Osmania
University, Dr. B.R.Ambedkar Open University, Acharya N.G.
Ranga Agricultural University, Potti Sreeramulu Telugu
University and the Work-Charged establishment who are
drawing pay in the Revised Pay Scales of 2005 and who are
working in the territorial limits of Greater Hyderabad Municipal
Corporation as per G.O.Ms.No.261, M.A.&U.D. Department,
dated: 16-4-2007.

These orders are not applicable to:-

- (a) Those employees who opt to remain in the Andhra
Pradesh Revised Pay Scales, 1999;
- (b) Teachers working in the Universities, affiliated
degree colleges both under Government and aided
managements who are drawing pay in the Andhra Pradesh
Revised UGC/ICAR/AICTE Pay Scales, 1986/1996; and
- (c) Officers belonging to All India Services;

7. In respect of Andhra Pradesh Higher Judicial Services
and Andhra Pradesh State Judicial Services who are
governed by the First National Judicial Pay Commission,
orders will be issued separately.

8. These orders shall come into force with effect from 01-11-2007. The arrears from **01-11-2007 to 31-12-2007** on the revised rates of 30% HRA shall be credited to the General Provident Fund Accounts of the employees. The revised rates of HRA shall be paid in cash along with the salary from the month of **January, 2008** payable from the month of **February, 2008**.

9. Necessary amendments to the A.P. Public Employment (House Rent Allowance) Rules, 1988 shall be issued separately.

The following notification shall be published in the Andhra Pradesh Gazettee.

NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Andhra Pradesh hereby makes the following Adhoc rules for the Post of Assistant Director in School Education Department.

ADHOC RULES

1.CONSTITUTION:

The Post of Assistant Director shall constitute a distinct category in Andhra Pradesh School Educational Service.

2. METHOD OF APPOINTMENT

The Appointment to the post shall be made by recruitment by transfer from Superintendent/Auditor i.e., class A category-I of Andhra Pradesh Ministerial service.

NOTE: A combined seniority list of all eligible Superintendents/Auditors of Andhra Pradesh Ministerial Service in School Education Department shall be prepared and considered for appointment.

3. APPOINTING AUTHORITY:

The Director of School Education shall be the appointing authority to the said post.

4. Rule of Reservation:

The rule of reservation in promotion shall be followed as per the Government orders issued from time to time.

5. Qualifications:

(i) Qualification is Prescribed

No person shall be eligible for appointment to the said post unless he posses a Bachelor Degree in Arts/Science/Commerce of any University in India established or incorporated by or under central Act, Provisional Act or of State Act and institution recongnized by the University Grants Commission.

6. Minimum Service:

No person shall be eligible for appointment to the said post unless he has put in not less than three years of service in the category/class from which recruitment by transfer is to be made.

7.Probation:

Every person appointed to the said post shall be on probation for a total period of one year on duty within a continuous period of two years from the date on which he/she commenced probation.

8. Tests:

(i) Every person appointed to the said post shall pass the tests laid down in column (1) subject to the condition in column(2)

Tests	Conditions
(i) Departmental test for Gazetted Officers of the Education Department	Should have passed at the time of appointment
(ii) Accounts test for Executive Officers	
(iii) Special language test for the officers of the Education Department in Telugu of Higher Standard	
(iv) Special Language Test for the Officers of the Education Department in Hindi/Urdu of Lower Standard	

- (ii) Where a test is prescribed of a language of higher standard a person shall be exempted from passing the test if he/she has passed the language as a subject in Intermediate examination or its equivalent or higher degree. Where a test is prescribed of a language of lower standard a person shall be exempted from passing the test if he/she has passed the language as a subject in SSC Examination or its equivalent or higher degree.
- (iii) All persons who have completed the age of 50 years on the date of appointment to the post shall be exempted from passing the tests referred to in column(1) of the table under sub-rule(i)
